ORDINANCE #16-08

AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE BOROUGH OF CHATHAM, COUNTY OF MORRIS, STATE OF NEW JERSEY AMENDING CHAPTER 139 OF THE BOROUGH CODE TO REGULATE STOPPING/STANDING ALONG A SECTION OF DELLWOOD AVENUE DURING CERTAIN TIMES

WHEREAS, the Borough’s Long Range Traffic and Pedestrian Safety Committee has recommended prohibiting stopping or standing along a section of Dellwood Avenue during certain times on school days in order to facilitate the safe pedestrian crossing to and from Chatham High School and Lafayette Elementary School; and

WHEREAS, upon the Committee’s recommendation, the Mayor and Borough Council wish to prohibit stopping or standing along a section of Dellwood Avenue in the Borough between the hours of 8:00 a.m. to 9:00 a.m. and 3:00 p.m. to 4:00 p.m. on school days only.

NOW THEREFORE BE IT ORDAINED by the Mayor and Council of the Borough of Chatham, County of Morris, and State of New Jersey as follows:

Section 1. Chapter 139 of the Borough Code be and hereby is amended as follows:

§139-25 Schedule II: No Stopping or Standing.

Name of Street	Side	Hours	Location
Dellwood Avenue	West	8:00 a.m. to 9:00 a.m. and 3:00 p.m. to 4:00 p.m., school days	From the Chatham Township-Chatham Borough corporate line to a point 244 feet north thereof
Dellwood Avenue	East	8:00 a.m. to 9:00 a.m. and 3:00 p.m. to 4:00 p.m., school days	From the Chatham Township-Chatham Borough corporate line to a point 320 feet north thereof

NOTE: The remainder of this Section remains the same.

Section 2. If any section, paragraph, subsection, clause, or provision of this Ordinance shall be adjudged by the courts to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause or provisions so adjudicated, and the remainder of the Ordinance shall be deemed valid and effective.

Section 3. Any ordinances or parts thereof in conflict with the provisions of this Ordinance are repealed to the extent of such conflict.

Section 4. This Ordinance shall take effect on upon passage and publication in accordance with applicable law.
