REPORTS

1. Nursing Report: Bridget Colendenski read the public nursing report.
 - The Chatham school audits were performed. Some paperwork was missing, the schools were then deemed compliant after the parents provided the information.
 - Bob Weber asked if most instances are paperwork related, or parents not vaccinating. She confirmed most are vaccinated and just missing paperwork.
 - Lisa DeRosa asked if there was more of an uptick of religious exemptions, she said not more than usual.
 - Kay asked if there were any covid vaccination clinics scheduled; Megan added there were some in their other towns, 56% of children 5-11 are fully vaccinated, and 66% of people who are eligible for booster have received.
 2. R.E.H.S. Report: Beau Preston reviewed the REHS report.
 - Beau performed a preoperational inspection and some preapprovals for temporary food vendors for a breakfast at one of the schools.
 - He returned to a local restaurant for a re-inspection; he will continue to follow up for compliance.
 - He responded to a complaint in See Click Fix on dog droppings at an apartment complex.
 - He reviewed a garbage complaint in the post office plaza lot; they were told to clean it up and they complied.
 3. Health Officer Monthly Update: Megan Avallone reviewed the health officer report.
 - We just reached the two-year milestone of the first case of covid-19 in NJ. Westfield had 20,718 cases reported. They have administered 3,287 vaccinations through the end of February. For Chatham Borough 1,626 covid cases throughout the last 24 months. The new map shows moderate levels of infection from the height of omicron. The kids will be taking off their masks in school, per the Governor's orders. They will be focusing on home visits and office visits.
 - Dr. Scherer added that a tight fitting mask is sufficient for kids as opposed to the cloth masks; Megan added that the pediatric surgical masks are good.
