RESOLUTION #14-123 RESOLUTION TO APPOINT BARBARA HEIMRICH TO THE MEMORIAL POOL ADVISORY COMMITTEE C-02/21/14 4

BE IT RESOLVED, by the Mayor and Council of the Borough of Chatham that Barbara Heimrich be appointed to the Memorial Pool Advisory Committee with a term to expire on December 31, 2014.

FINANCE

RESOLUTION #14-124 RESOLUTION CALLING ON THE LEGISLATURE TO MAKE PERMANENT THE 2% CAP ON INTEREST ARBITRATION AWARDS

WHEREAS, on December 21, 2010, Governor Christie signed into law reforms to the arbitration process that took effect January 1, 2011; and

WHEREAS, the reforms capped arbitration awards on economic factors to no more than 2%, provided for random selection of arbitrators, expedited the determination of awards, required the arbitrator to provide a written report detailing the weight accorded to each of the required considerations and expedited the appeal process; and

WHEREAS, these reforms marked a dramatic change to the arbitration process and have helped municipalities to control the never-ending rise in public safety personnel costs; and

WHEREAS, a key element of the reforms, capping arbitration awards on economic factors to no more than 2% of the property tax levy will expire on April 1, 2014; and

WHEREAS, while municipalities are statutorily limited to raise their property tax levy by no more than 2%, with very limited exceptions, failure to extend the 2% cap on interest arbitration awards will force municipalities throughout the State to further reduce or even eliminate crucial services, personnel, and long-overdue infrastructure improvement projects in order to fund an arbitration award.

WHEREAS, the 2% Interest arbitration cap has controlled one of the largest municipal expense, public safety salaries, not only through arbitration awards but through contract negotiations; and

WHEREAS, absent further action by the Legislature, any contract that expires on or after April 1, 2014, will be subject to all new procedures and requirements, EXCEPT the 2% awards cap; and

WHEREAS, without those limits, arbitrators will be able to impose awards that do not account for the 2% limit on the property tax levy, which would immediately threaten funding for all other municipal services; and

WHEREAS, without the 2% cap on Interest arbitration awards but with the 2% cap on property tax levy local budget makers could be forced to reduce other essential municipal services to fund an arbitration award.

BE IT RESOLVED, that the Chatham Borough Council urges the Legislature to permanently extend the 2% cap on interest arbitration awards prior to the April 1, 2014 sunset; and

BE IT FURTHER RESOLVED, that a that a copy of this duly adopted resolution be forwarded to Senate President Stephen Sweeney, Assembly Speaker Vincent Prieto, Senator Thomas H. Kean, Jr., Assemblywoman Nancy F. Munoz, Assemblyman Jon M. Bramnick, Governor Christie, and the New Jersey State League of Municipalities.

RESOLUTION #14-129 RESOLUTION TO CONSENT TO AMEND THE MORRIS COUNTY SOLID WASTE MANAGEMENT PLAN THROUGH ADMINISTRATIVE ACTION TO INCLUDE S. ROTONDI & SONS, INC.'S VEGETATIVE WASTE ACTIVITIES ON BLOCK 140, LOT 17 INTO DEP PERMIT No. REC100002

WHEREAS, S. Rotondi & Sons, Inc. is located at 3 Watchung Avenue, on Block 140, Lot 16 and Block 140, Lot 17; and

WHEREAS, S. Rotondi & Sons, Inc. ("Rotondi") has made a Request for Plan Modification to the Morris County Solid Waste Management Plan ("Request") in a letter dated November 13, 2013; and

WHEREAS, the Request seeks to include Rotondi's vegetative recycling operations located upon Block 140, Lot 17 within its New Jersey Department of Environmental Protect ("DEP")approved Class B and C Facility located upon Block 140, Lot 6 at their common address of 3 Watchung Avenue (the "Facility"); and

WHEREAS, the Facility has been in operation as a vegetative waste recycling business for over twenty years and the current DEP approval references the ongoing business being conducted on Block 140, Lot 17; and

WHEREAS, pursuant to DEP Permit No.: REC100002, Rotondi is authorized to receive, process and/or transferred leaves, grass clippings, brush and tree branches upon Block 140, Lot 16; and

WHEREAS, the Facility stores and sells final product including topsoil, compost, wood chips, mulch, dyed mulch, stone and fire wood; and

WHEREAS, Rotondi's seeks to include its vegetative waste operation on Block 140, Lot 17 into the aforesaid permit to formally incorporate the storage of Class B material including

brush, tree parts, whole trees, stumps, clean wood (unpainted and untreated), dimensional wood and wood pallets and the processing of said wood material via a Morbark Tub Grinder within Permit No.: REC100002; and

WHEREAS, the inclusion of the aforesaid vegetative recycling operations on Block 140, Lot 17 will not increase or change the truck traffic or volume of materials at the Facility; and

WHEREAS, the Borough of Chatham has reviewed the Request and consents thereto; and

WHEREAS, Rotundi has agreed to grant the Borough of Chatham an easement across its property for the purpose of establishing a nature trail.

(4) Retrofitting of two final clarifiers

(5) Other such work as may be reasonable necessary in order to complete the replacement and/or retrofitting of the aforementioned digester and clarifiers; and

WHEREAS, the New Jersey Environmental Infrastructure Trust working in partnership with

New Jersey Department of Environmental Protection (hereinafter collectively referred to as the "Environmental Infrastructure Trust") provides qualified borrowers with low interest loans to undertake water quality, wastewater treatment and storm water discharge improvement projects; and

WHEREAS, the Joint Meeting intends to file an application with Environmental Infrastructure Trust in order to finance in whole or in part its proposed 2015 Facility Improvement Program for the Molitor Water Pollution Control Facility; and

WHEREAS, each member municipality of the Joint Meeting must join in, consent to, support and endorse the application that the Joint Meeting intends to make to the Environmental Infrastructure Trust for the financing of its 2015 Facility Improvement Program; and
