REGULAR MEETING OF THE MAYOR AND BOROUGH COUNCIL

September 22, 2014 MINUTES

Mayor Bruce A. Harris called the Regular Council Meeting of the Borough of Chatham to order on Monday, September 22, 2014 at 7:30 p.m. in the Council Chambers in the Municipal Building, 54 Fairmount Avenue, Chatham, New Jersey.

SALUTE TO FLAG

The Mayor and Borough Council led the assembled in the Pledge of Allegiance.

MOMENT OF SILENCE

Mayor Harris asked for a moment of silence for those who have given their lives for our country.

STATEMENT OF ADEQUATE NOTICE

Robin R. Kline, Municipal Clerk, read the following statement of adequate notice:

Adequate notice of this meeting had been provided on January 2, 2014 in accordance with N.J.S.A. 10:4-10, by including same in the Annual Meeting Notice, a copy of which was posted on the Municipal Bulletin Board located on the main floor in the Municipal Building; e-mailed to the Independent Press, the Morris County Daily Record, the Star Ledger, the Chatham Courier, the Chatham Patch, and The Alternative Press; and, such Annual Meeting Notice was filed with the Borough Clerk.

ROLL CALL

On a call of the roll the following officials were present:

Mayor Bruce A. Harris opened the meeting by announcing that Chatham Borough will be paying tribute to Patrolman Jeffrey Battiloro, Patrolman Matthew Belcastro and Chatham Borough resident Mr. Brian Hart for their roles in apprehending a robbery suspect at the HSBC Bank earlier in the year. Mayor Harris recognized and welcomed Chatham Township Mayor Kevin Sullivan, who was in attendance.

Mayor Harris further announced that after all three Resolutions of Commendation have been read and approved by the Council, he would turn the meeting over to Council Member James Collander, who would introduce Chief Philip Crosson and Lieutenant Brian Gibbons and proceed with the presentation of the Meritorious Service Award to Patrolman Jeffrey Battiloro and to Patrolman Matthew Belcastro, and presentation of the Civilian Service Award to Mr. Brian Hart.

Mayor Harris asked Council Member James J. Collander to read the following Resolution:

RESOLUTION #14-284

RESOLUTION OF SPECIAL COMMENDATION TO CHATHAM BOROUGH RESIDENT BRIAN HART FOR HIS COURAGEOUS ACTIONS AND SUPPORT DURING A DANGEROUS POLICE ENCOUNTER

WHEREAS, on April 9, 2014, Patrolman Jeffrey Battiloro and Patrolman Matthew Belcastro were actively engaged in attempting to apprehend a physically combative alleged robbery suspect fleeing the HSBC Bank; and

WHEREAS, Patrolman Belcastro pursued the suspect on foot across Main Street onto Dunbar Street making physical contact with the suspect near Martin Place. During the encounter Patrolman Belcastro sustained significant injuries; however, he maintained steadfast in his duties subduing the suspect to the ground; and

WHEREAS, Patrolman Belcastro continued to struggle with the suspect attempting to secure him when Chatham Borough resident Brian Hart courageously announced his presence and willingness to assist the officer without regard for his own safety; and

WHEREAS, Brian Hart helped maintain physical control of the suspect as Patrolman Belcastro secured the suspect in handcuffs; and

WHEREAS, the courageous actions of Brian Hart in this dangerous encounter assisted in the apprehension of the suspect who allegedly committed robbery at the HSBC Bank on Main Street.

BE IT RESOLVED, by the Mayor and Council of the Borough of Chatham, in the County of Morris, State of New Jersey that they hereby commend Chatham Borough resident Brian Hart for his courageous actions in assisting the Chatham Borough Police Department in a dangerous encounter; and

BE IT FURTHER RESOLVED, that through this special commendation, the Mayor and Council of the Borough of Chatham wishes to pay tribute to Brian Hart for his courageous service in assisting the law enforcement community.

Council Member Collander moved to approve Resolution #14-284. Motion seconded by Council President Victoria Fife. A voice vote was taken and Resolution #14-284 was approved unanimously.

Mayor Harris asked Council Member James J. Collander to read the following Resolution:

RESOLUTION #14-285

RESOLUTION OF SPECIAL COMMENDATION TO PATROLMAN JEFFREY BATTILORO #118, CHATHAM BOROUGH POLICE DEPARTMENT FOR MERITORIOUS SERVICE IN A DANGEROUS ENCOUNTER

WHEREAS, on April 9, 2014, Patrolman Battiloro, was dispatched to the HSBC Bank on a report of an individual attempting to commit a fraudulent transaction; and

WHEREAS, upon arrival Patrolman Battiloro was advised that the subject standing at the teller window was attempting to make a fraudulent withdrawal of funds using a fake identification card; and

WHEREAS, Patrolman Battiloro approached the suspect and requested to speak with him, upon receiving no acknowledgement, he again requested to speak with the suspect. The suspect then

looked at Patrolman Battiloro, turned and attempted to flee the bank. Patrolman Battiloro pursued the suspect through the bank and tackled him inside the lobby; and

WHEREAS, a struggle ensued and the suspect began to punch Patrolman Battiloro and they continued to wrestle and in the process they fell over a glass table. The suspect broke free from the officers grasp and exited the bank towards Main Street; and

WHEREAS, Patrolman Matthew Belcastro entered the HSBC bank through the side door and began to chase the suspect on foot toward Dunbar Street; and

WHEREAS, Patrolman Battiloro coordinated radio communications to other responding police units and unable to give chase due to injuries sustained in the struggle, Patrolman Battiloro returned to his patrol vehicle and drove toward Dunbar Street to assist Patrolman Belcastro who had broadcast over the radio that he believed that he had injured his shoulder and was requesting assistance; and

WHEREAS, upon arrival, Patrolman Battiloro observed that the suspect had been captured and placed under arrest by Patrolman Belcastro; and

WHEREAS, both officers were later transported to the hospital and treated for a variety of injuries sustained during this investigation; and

WHEREAS, the outstanding performance of Patrolman Battiloro in this dangerous encounter led to the apprehension of the suspect who committed an alleged robbery at the HSBC Bank on Main Street.

BE IT RESOLVED, by the Mayor and Council of the Borough of Chatham, in the County of Morris, State of New Jersey commend Patrolman Jeffrey Battiloro in his exemplary conduct and meritorious service in a dangerous encounter; and

BE IT FURTHER RESOLVED, that through this special commendation, the Mayor and Council of the Borough of Chatham honor the service of Patrolman Jeffrey Battiloro and pay tribute to Patrolman Jeffrey Battiloro as an outstanding member of the law enforcement community.

Council Member Collander moved to approve Resolution #14-285. Motion seconded by Council Member Gerald Helfrich. A voice vote was taken and Resolution #14-285 was approved unanimously.

Mayor Harris asked Council Member James J. Collander to read the following Resolution:

RESOLUTION #14-286

RESOLUTION OF SPECIAL COMMENDATION TO PATROLMAN MATTHEW BELCASTRO #137, CHATHAM BOROUGH POLICE DEPARTMENT FOR MERITORIOUS SERVICE IN A DANGEROUS ENCOUNTER

WHEREAS, on April 9, 2014, Patrolman Matthew Belcastro heard the dispatch of a call to the HSBC Bank for a report of an individual attempting to commit a fraudulent transaction; and

WHEREAS, while enroute to the HSBC Bank, Patrolman Belcastro heard Patrolman Jeffrey Battiloro advise dispatch that he was on the scene; and

WHEREAS, moments later, Patrolman Belcastro arrived at the bank and upon his approach, he observed Patrolman Battiloro being violently punched in his shoulder by an unknown male subject who was attempting to evade apprehension; and

WHEREAS, before he could even open the door to enter the bank, Patrolman Belcastro heard Patrolman Battiloro shout for him to secure the suspect who had fled through the front door toward Main Street; and WHEREAS, having witnessed an aggravated assault on a police officer, Patrolman Belcastro immediately gave chase; and

WHEREAS, Patrolman Belcastro continued to give chase across Main Street and onto Dunbar Street ordering the suspect to stop however, the suspect did not comply. Upon closing the gap between himself and the suspect, Patrolman Belcastro grabbed the suspect's shirt causing them both to fall to the ground at which time he lost contact with the suspect; and

WHEREAS, during the fall, Patrolman Belcastro struck the asphalt at which time he heard a snap and his right arm immediately became numb; and

WHEREAS, at this time, Patrolman Belcastro was able to return to his feet and in doing so, noted that the suspect began to run again but quickly stopped. Patrolman Belcastro then drew his service weapon and commanded the suspect to the ground several times. The suspect did not comply with the commands and began to move toward the officer closing the gap between them; and

WHEREAS, when the suspect was about 10 feet from Patrolman Belcastro he suddenly increased his pace and began to run at him. Patrolman Belcastro quickly holstered his service weapon and began running toward the suspect making physical contact with him. Patrolman Belcastro struggled with the suspect avoiding some punches thrown by the suspect; and

WHEREAS, at this time, an unknown male ran to assist Patrolman Belcastro as he secured the suspect in handcuffs; and

WHEREAS, both officers were later transported to the hospital and treated for a variety of injuries sustained during this investigation; and

WHEREAS, the outstanding performance of Patrolman Belcastro in this dangerous encounter led to the apprehension of the suspect who committed alleged robbery at the HSBC Bank on Main Street.

BE IT RESOLVED, by the Mayor and Council of the Borough of Chatham, County of Morris, State of New Jersey commend Patrolman Belcastro in his exemplary conduct and meritorious service in a dangerous encounter; and

BE IT FURTHER RESOLVED, that through this special commendation, the Mayor and Council of the Borough of Chatham honor the service of Patrolman Belcastro and pay tribute to Patrolman Belcastro as an outstanding member of the law enforcement community.

Council Member Collander moved to approve Resolution #14-286. Motion seconded by Council President Victoria Fife. A voice vote was taken and Resolution #14-286 was approved unanimously.

Mayor Bruce Harris, Council Member James Collander, Chief Philip Crosson and Lt. Brian Gibbons presented the Meritorious Service Award to Patrolman Jeffrey Battiloro and Patrolman Matthew Belcastro. Mr. Brian Hart, a retired NYPD officer, was presented with the Civilian Service Award recognizing his courageous service in assisting the law enforcement community. The presentations were met with rising applause.

Mayor Harris called for a brief recess.

Mayor Bruce Harris reconvened the meeting and asked Council President Fife to read the following Resolution:

Council President Victoria Fife moved to approve Resolution #14-287. Motion seconded by Council Member Gerald Helfrich. A voice vote was taken and Resolution #14-287 was approved unanimously.

DISCUSSION ITEMS

<u>Cub Scout Recruitment Event Facility Use Request</u> – Mr. Tony Britt, Assistant Scoutmaster, Chatham Troop #8, reported that the Boy Scouts of America are planning a Boy Scout/Cub Scout outdoor activity and recruitment event for Friday, September 26th and wish to seek approval to use the Borough's mulch area for a campfire gathering that evening. Mr. Britt reported permissions have been received from Chatham School District Superintendent and the Milton Avenue School Principal to use the baseball and soccer fields for outdoor day activities. Preliminary approvals have been given by Chatham Recreation pending completion of paperwork and proof of insurance. Mr. Britt stated he has been working with Mr. Falzarano, Mr. Williams and Mr. Nugent to discuss logistics and compliance issues for the use of the mulch area and compliance of fire safety regulations with respect to the campfire. At the conclusion of his presentation, Mr. Britt confirmed that the Boy Scouts will practice its "Leave no Trace" principle and will ensure that all remnants from the campfire are removed.

<u>Shade Tree Specimen Selection</u> – Mr. Patrick Carroll, a Commissioner of the Chatham Borough Shade Tree Commission, presented an informative slide presentation on the role of the Shade Tree Commission and the benefits and value trees add to a community. He provided a brief update on several activities sponsored by the Shade Tree Commission over the past year and reported that one of the goals of Shade Tree Commission is to keep the number of trees in the Borough neutral year-toyear, although this has been difficult to achieve in the aftermath of Superstorm Sandy in 2012 and heavy snowfall realized for the last few winters. Commissioner Carroll further reported that 40 requests for replacement trees have been received this year, but only 31 replacement trees will be planted in the fall due to budgetary constraints. Tree planting requests not accommodated in this fall season would be added to the spring 2015 planting list. Commissioner Carroll confirmed a replacement memorial tree will be planted at the Library this fall.

Commissioner Carroll stated small trees, such as Dogwoods, Eastern Red Buds or Washington Hawthorns, would be planted in sites having overhead power lines and/or sidewalk constraints. Medium-sized trees, such as Red Maples, Zelkovas, Pin Oaks and Lacebark Elm, would be planted in sites having no overhead power lines or sidewalk constraints. The Shade Tree Commission has set a goal to plant 80 trees each year and will request a budget increase to meet that goal next year. Commissioner Carroll suggested the Borough should consider establishing a tree nursery to help defray tree purchasing costs in future years. On behalf of the Shade Tree Commission, Commissioner Carroll thanked the Mayor and Council for their continued support of their programs, activities, and public awareness campaigns.

Council Member John Holman inquired whether the Shade Tree Commission provides a listing of recommended trees asked if that could be shared with residents to help them select appropriate tree species for planting on their properties.

Council President Victoria Fife further suggested the Borough should incorporate the Shade Tree Commission's listing of recommended trees in the Borough's tree removal application.

Mayor Bruce Harris encouraged the Shade Tree Commission to examine open space resources within the Borough that may accommodate a tree nursery and to also talk with PSE&G about potential land opportunities. Mayor Harris stated the Shade Tree Commission's listing of recommended trees should be posted on their webpage for quick reference.

Council Member Gerald Helfrich encouraged the Shade Tree Commission to select large tree species for replanting at sites that would allow for a larger tree to continue maintaining those tree-lined streets where larger trees currently exist in the Borough.

Mr. Falzarano inquired if the memorial tree at the Library that was damaged during Hurricane Sandy could be replaced. Commissioner Carroll confirmed a replacement tree has been scheduled for planting this fall.

<u>Cross Country Long Distance Recreation Program</u> – Mr. Jim LeMon, Chairperson of the Joint Recreation Program, reported 166 cross-country participants in grades 3 through 8 have registered with the new cross country recreation program. Each participant is charged a \$55 fee and the cross county program does not require further funding from the Recreation Department. The program started in July 2014 and participates in the Lakeland Junior League meets. Weekly practices are held in Chatham and the first meet took place in Morris Plains on Sunday, September 7th, with Chatham being the largest participant in the meet. Start-up costs for the cross country program were funded by a donation from the Chatham Athletic Fund and the Chatham Wrestling Club paid for the Lakeland Junior League registration fee. Mr. LeMon reported the program anticipates it will move into club status next spring and thanked the volunteer coach/trainers, adult team leaders, the Chatham Athletic Foundation, Chatham Recreation for supporting the program.

<u>Farmers' Market Permanent Seating</u> – Mr. Joseph Mikulewicz, a founding member of the Chatham Farmers' Market Advisory Committee, reported the Farmers' Market will be operating nine more Saturdays this year, with 30 vendors rotating weekly over a 24-week market season. The Committee is proposing to install permanent seating at the Farmers' Market to accommodate shoppers, offering a convenient place to eat as they shop and creating a meeting location for friends and neighbors. The proposed seating includes two 8' streetscape benches to be installed along the Fairmount Avenue entrance to the Farmers' Market and three outdoor picnic tables to be installed adjacent to the Farmers' Market at Lum Field. Mr. Mikulewicz presented vendor images of the bench and picnic tables, which will be purchased through the state contract program. Mr. Mikulewicz presented the Farmers' Market 2014 budget detail together with the 2014 revenue and expense report.

Council Member John Holman confirmed that the market vendors support the permanent seating proposal and encouraged the Council to consider its support of the proposal. The Mayor and Council concurred and voiced their approval of the permanent seating proposal for the Farmers' Market.

<u>Leaf Pick-up Update</u> – Mr. Tony Torello, Deputy Public Works Director, reported the leaf collection program will begin October 14th in accordance to the following schedule: Zones 5 & 6: Oct. 14th through Oct. 17th and Nov. 3rd through Nov. 7th; Zones 3 & 4: Oct. 20th through Oct. 24th and Nov. 10th through Nov. 14th; and, Zones 1 & 2: Oct. 27th through Oct. 31st and Nov. 17th through Nov. 21st. He

reminded residents not to place leaves on the streets and to keep leaves away from storm drains. Additionally, starting October 20th, the mulch site will be open Monday through Friday, 1:00 p.m. to 3:00 p.m., and Saturdays, 12:00 p.m. to 4:00 p.m., to better serve residents who wish to bring in their leaves. The Mulch site will close to the public on Saturday, December 6, 2014.

<u>Home Security</u> – Chief Philip Crosson and Lt. Brian Gibbons provided an update on proactive steps taken by the Chatham Borough Police Department to address the recent burglaries that have taken place in the Borough. Chief Crosson reported the police department is actively working with other law enforcement agencies and have increased night time patrols and surveillance. The Chatham Alert system is being utilized to advise residents to take proactive steps in securing all doors and windows, including garage doors. Chief Crosson encouraged residents to leave exterior lights on to assist patrols and to move exterior items, such as lawn furniture, away from windows. Further, homeowners with home alarm systems are encouraged to set their alarm systems when away from home and during night hours, and emphasized that the crime scene should not be altered until the police have investigated the scene. In closing, Chief Crosson stated that the police department will continue to take extra measures to keep our community safe and secure.

Council Member James Collander inquired whether the spike in home burglaries is specific to the Chatham Borough. Chief Crosson responded that home burglaries are occurring throughout the county and in neighboring communities. Law enforcement agencies are working together and sharing information to apprehend and arrest all criminals.

Mayor Bruce Harris thanked Chief Crosson, Lt. Gibbons and the police force for their immediate response and efforts in getting out additional patrols and police surveillance.

Mayor Bruce A. Harris reported he attended the 9/11 Memorial commemoration, which was very moving, and expressed his appreciation to the 9/11 Memorial Advisory Committee for organizing the commemoration.

ADMINISTRATOR'S REPORT

Mr. Robert Falzarano reported that the 2015-2016 Grass and Property Maintenance bid proposals have been received and the contract award is scheduled for the October 27th meeting of the Mayor and Council. Mr. Falzarano further reported interviews for the Director of Finance position have taken place and the Personnel Committee will introduce the final candidate to the Mayor and Council for a final interview in closed session later this evening. Mr. Falzarano provided an update on the Borough's dumpster ordinance, which has been reviewed by Mr. Lott. Mr. Lott has advised that the ordinance is sufficient as currently enacted and further advised the Borough can enforce the provisions of the dumpster ordinance. Lastly, Mr. Falzarano confirmed the 2015 budget request forms have been sent to the department heads, boards and commissions. The 2015 budget submissions are due October 15th.

RESOLUTION CERTIFIYING RECEIPT AND REVIEW OF THE 2013 AUDIT REPORT

WHEREAS, N.J.S.A. 40A:5-4 requires the Governing Body of every local unit to have made an annual audit of its books, accounts and financial transactions; and

Council Member Gerald Helfrich introduced Ordinance #14-07 by title as follows:

ORDINANCE #14-07

AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE BOROUGH OF CHATHAM, COUNTY OF MORRIS, STATE OF NEW JERSEY PROVIDING FOR THE VACATION OF A PORTION OF THE BOROUGH RIGHT-OF-WAY KNOWN AS 11 EDGEWOOD ROAD, BLOCK 15, LOT 17 IN THE BOROUGH OF CHATHAM.

WHEREAS, pursuant to N.J.S.A. 40:67-1 et seq., the governing body of a municipality may make, amend, repeal and enforce an ordinance to vacate any public street, highway, lane or alley, or any portion thereof; and

WHEREAS, the Borough of Chatham (the "Borough") has received a request from Michael and Ellen M. Blazoski with an address of 9 Edgewood Road, Block 15, Lot 11 and William Calvert III and Janet B. Calvert with an address of 13 Edgewood Road, Block 15, Lot 12 on the official Tax Map of the Borough (collectively, the "Adjacent Property Owners"), for the Borough to vacate the Borough right-of-way known as 11 Edgewood Road, Block 15, Lot 17 immediately adjacent to their properties; and

WHEREAS, the area to be vacated is more particularly described by the metes and bounds descriptions entitled "A PORTION OF TAX LOT 17 IN BLOCK 15 TO BE ANNEXED TO TAX LOT 11 IN BLOCK 15 LANDS NOW OR FORMERLY OF MICHAEL AND ELLEN M. BLAZOSKI DESCRIBED IN DEED BOOK 3784 AT PAGE 209," attached hereto as Exhibit "A" and together with "A PORTION OF TAX LOT 17 IN BLOCK 15 TO BE ANNEXED TO TAX LOT 12 IN BLOCK 15 LANDS NOW OR FORMERLY OF WILLIAM, III AND JANET B. CALVERT DESCRIBED IN DEED BOOK 6036 AT PAGE 8," attached hereto as Exhibit "B"; and as more fully delineated on a survey entitled "SURVEY OF PROPERTY PART OF LOT 17 BLOCK 15 EDGEWOOD ROAD BOROUGH OF CHATHAM MORRIS COUNTY, NEW JERSEY," attached hereto as Exhibit "C", which description and survey were prepared by DPK CONSULTING, 147 Union Ave., Ste. 1C, Middlesex, NJ 08846, last revised June 10, 2014; and

WHEREAS, the Mayor and Borough Council have determined that the area to be vacated is no longer needed for public purposes; and

WHEREAS, the Mayor and Borough Council are of the opinion that it is in the best interests of the Borough and its citizenry to vacate the aforementioned right-of-way; and

WHEREAS, upon adoption of this vacation ordinance, one half of the area to be vacated will be thereby conveyed to each of the Adjoining Property Owners in its "as is" condition; and

WHEREAS, the Adjacent Property Owners have agreed to reimburse the Borough for all reasonable professional fees expended with regard to the vacation and have posted and will maintain the escrow required by § 244-50.1 et seq. of the Borough Code.

BE IT ORDAINED, by the Mayor and Council of the Borough of Chatham, County of Morris, and State of New Jersey as follows:

Section 1. Subject to the conditions set forth herein, the rights of the public in and to the Borough right-of-way known as 11 Edgewood Road, Block 15, Lot 17, as described in Exhibits "A" and "B" and as more fully depicted on Exhibit "C", all being attached hereto and made a part hereof, are hereby released, extinguished and vacated.

Section 2. The area hereby vacated, is conveyed to the Adjacent Property Owners of, and shall merge, consolidate with, and become a part of their respective adjoining properties identified as Block 15, Lots 11 and 12 on the Official Tax Map of the Borough as described in Exhibits A and B and depicted on Exhibit C hereto.

Section 3. The vacation hereby enacted expressly reserves and excepts from vacation all rights and privileges possessed by public utilities, as defined by R.S. 48:2-13, and by any cable television company, as defined in the "Cable Television Act" P.L. 1972c. 186 (c.48:5A-1 et. seq.), to maintain, repair and replace their existing facilities in, adjacent to, over or under the vacated right-of-way.

Section 4. The vacation hereby enacted further expressly reserves to the Borough, its successors and assigns, and excepts from vacation a fifteen foot wide perpetual utility easement for the construction, reconstruction, inspection, maintenance, operation, use, and repair of any sanitary sewer, storm water drainage or public water supply improvements located on or under the vacated right-of-way including related appurtenances such as storm drain inlets, valve pits, shut off boxes, manholes, metering vaults, clean outs, and similar features which may be installed on or above the ground. The Borough, its successors and assigns shall give reasonable notice to the Adjacent Property Owners before commencing any work within easement area and shall generally restore the easement area as nearly as possible to the same condition as it may have been prior to the start of the work.

Section 5. It is the intent of the Mayor and Borough Council to vacate the aforementioned interests that the public may have in the aforementioned right-of-way, subject, however, to the reservations set forth herein, and to provide that the property shall be conveyed in its "as is" condition, to the Adjoining Property Owners for no further consideration.

Section 6. The Borough Clerk shall, within sixty (60) days of the effective date of this Ordinance, file a copy of this Ordinance certified by her under the seal of the Borough to be a true copy thereof, together with proof of publication thereof, in the office of the Clerk of the County of Morris in the Book of Vacations, in accordance with applicable law.

Section 7. If any section, paragraph, subsection, clause or provision of this Ordinance shall be adjudged by the courts to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause or provisions so adjudicated, and the remainder of the Ordinance shall be deemed valid and effective.

Section 8. Any ordinances or parts thereof in conflict with the provisions of this Ordinance are repealed to the extent of such conflict.

Section 9. This Ordinance shall take effect upon passage and publication in accordance with applicable law.


