June 25, 2018 MINUTES

Mayor Bruce A. Harris called the Regular Council Meeting of the Borough of Chatham to order on Monday, June 25, 2018 at 7:30 p.m. in the Council Chambers in Borough Hall, 54 Fairmount Avenue, Chatham, New Jersey.

SALUTE TO FLAG

Mayor Harris and the Borough Council led the assembled in the Pledge of Allegiance.

MOMENT OF SILENCE

Mayor Harris asked for a moment of silence for those who have given their lives for our country.

Mayor Harris opened the meeting by announcing that Joseph Treloar, who was in attendance, was being appointed to the Environmental Commission and removed the appointing Resolution, Resolution #18-244, from the Consent Agenda for action at this time. WHEREAS, there exists a 1st Alternate Member vacancy on the Chatham Borough Environmental Commission with a 2-year term to expire on December 31, 2018; and

WHEREAS, Joseph Treloar has expressed interest in being appointed to the Environmental Commission and has submitted a volunteer application for consideration; and

WHEREAS, N.J.S.A. 40:56-1 sets forth that the appointment of Alternate Members to an Environmental Commission shall be made by the Council; and

WHEREAS, the Council of the Borough of Chatham wishes to appoint Joseph Treloar to the vacant 1st Alternate Member position on the Chatham Borough Environmental Commission.

BE IT RESOLVED, by the Council of the Borough of Chatham that Joseph Treloar is hereby appointed as the 1st Alternate Member on the Environmental Commission to fill the vacant unexpired 2-year term, with such term expiring December 31, 2018; and

BE IT FURTHER RESOLVED that the Borough Clerk is authorized and directed to take all action necessary and appropriate to effectuate the terms of this Resolution in accordance with N.J.S.A. 40A:9-9.2a and the Code of the Borough Chatham, Chapter 3, §3.3.

Council Member Fife made a motion to approve Resolution #18-237. Council Member Collander seconded the motion. A vote was taken and Resolution #18-237 was approved unanimously.

RECUSALS

Mayor Harris asked if there are any recusals or abstentions to be submitted for the record with respect to any item listed on the agenda.

There were no recusals presented on the record.

DISCUSSION ITEM

Capital Projects Update – Mr. Vince DeNave, Borough Engineer, provided an update on the following 2018 capital projects:

1. The old artificial turf field at Lum Field has been removed. The new artificial turf field will be installed with an underlayment consisting of a blend of sand and a non-toxic cryogenic rubber. The artificial turf field will also be dressed with a “sole grind” layer of rubber derived from recycled footwear. It is anticipated that the project will take two weeks to complete.
2. The Weston Avenue Road Reconstruction project will begin after the July 4th holiday and will be completed before school opens in September. It is anticipated that traffic will only need to be detoured during the paving process and advance notice will be provided to residents. Inflow and infiltration (I & I) issues concerning the sanitary sewer system will also be reviewed during the road project.
3. The Department of Public Works has completed the drainage project on Bartow Lane and is currently working on the Meadow Road drainage project. The roads will be resurfaced after both drainage projects have been completed.
4. The Orchard Road resurfacing project is on hold pending a Planning Board application.
5. Morris County is in the process of finalizing the design specifications of the North Passaic Avenue Road Construction project.
6. PSE&G completed repaving Borough roads where the utility installed new gas lines. Mr. DeNave will review a punch list of items requiring additional work or repair by Tilcon, PSE&G’s contractor.

Mayor Harris inquired about the status of the exterior painting of the Borough’s water tanks. Mr. DeNave responded that the project has been put on hold due to the significant costs associated with the remediation of lead paint. He provided assurance that the lead paint does not pose a hazard and is not exfoliating from the exterior’s surface. The costs of remediation are largely due to the need to build an enclosure around the water tank when stripping and scraping the old paint in preparation of applying a new coat of paint.

MEETING OPEN TO THE PUBLIC

NOTICE OF PUBLIC COMMENT TIME LIMIT

Hearing of citizens during the Public Comment section of the Agenda is an opportunity for any member of the public to be heard about issues which are/are not topics scheduled for Public Hearing tonight. To help facilitate an orderly meeting, and to permit all to be heard, speakers are asked to limit their comments to a reasonable length of time.

Mayor Harris opened the meeting to the public.

Rozella Clyde, 33 Carmine Street, sought clarification on Ordinance #18-09, Section 199.12, Exceptions, which is on the agenda for first reading. She questioned whether Girl Scouts would be required to register with the Chief of Police before selling their cookies door-to-door in neighborhoods. If that were not the case, she suggested that Section 199.12 of the amended Ordinance should further clarify charitable and not-for-profit organizations and political activities that are exempt from registering with the Police Department.

Mr. Lott advised that constitutional issues needed to be addressed with the Borough’s current ordinance concerning commercial solicitation. He acknowledged that non-commercial compliance can be further clarified in the amended Ordinance.

Fran Drew, 32 Inwood Road, urged the governing body to pass a resolution opposing the federal government's policy of separating immigrant children from their parents who remain in federal custody during immigration proceedings.

Jack Drew, 32 Inwood Road, also urged the governing body to pass a resolution opposing the federal government's policy of separating immigrant children from their parents who remain in federal custody during immigration proceedings.

Seeing no one else wishing to comment, Mayor Harris closed the meeting to the public.

Council Member Kobylarz mentioned that he, Mayor Harris and Council President Resto had discussed drafting a resolution opposing the federal government's controversial policy of separating migrant children from their families at the southern border while federal immigration proceedings are adjudicated. He further mentioned that President Trump's recent executive order ended this policy, which he said eliminated the need for a Council resolution.

REPORTS

COUNCIL COMMITTEES

Budget and Finance - Council Member Hoffman reported that the 2019 budget process will begin in the month of August.

Long Range Traffic & Pedestrian Safety Planning - Council Member Collander reported that a new "No Parking" sign has been installed on the west side of South Passaic Avenue.

Public Safety & Emergency Services - Council Member Collander reported that the Police Department has placed a message board on Main Street encouraging residents to 'Register for Smart911. Register on AlertChathamBorough.'

Personnel - Council President Resto had nothing new to report. An update regarding the Police Chief hire will be provided in Closed Session.

Public Works Planning/Community Services - Council Member Fife had nothing new to report.

Shared Services & 3rd Party Agreements - Council Member Weber had nothing new to report.

MAYOR'S REPORT

Mayor Harris reported that the county held a public hearing last Thursday concerning the Morris County Draft Circulation Element. Although he was not able to attend the public hearing, he mentioned that he has submitted written comments on behalf of the Borough concerning the Borough's resolution supporting improvements to Route 24 and the Borough's proposal for a second train station in the Borough. Mayor Harris also reminded everyone of the upcoming July 4th activities, which includes the Fire Department's flag raising and inspection at the Firehouse in the morning followed by the parade at 10:30 a.m. and fireworks display in the evening. Lastly, Mayor Harris reported that the July 23rd Mayor and Council Meeting will be canceled unless an important matter creates the need for the governing body to meet.

ADMINISTRATOR'S REPORT

Mr. Williams reported that the Morris County Division of Mosquito Control will be spraying to reduce the annoyance and threat of disease caused by mosquitos. He encouraged residents to call his office or the Morris County Division of Mosquito Control should mosquito control be needed in a specific area of the Borough.

Mr. Williams also reported that Mr. Charles Salin will be the Grand Marshall of this year's July 4th parade. Mr. Salin is a 45-year member of the Chatham Volunteer Fire Department and past Fire Chief. He announced that the Fire Department Association will hold its flag raising at 9:15 a.m.; the parade begins at 10:30 a.m. along Main Street; and, the gates at the Chatham Middle School will open at 7:30 p.m. for musical entertainment and the fireworks display at dark.

Mr. Williams reported that the Borough received a Morris County Joint Insurance Fund Safety Incentive Program Award recognizing that during 2017 the Borough had no lost work time due to injuries. A \$750.00 gift certificate to purchase supplies from Grainger Industrial Supply was awarded to the Borough. He further reported that the Police Department was selected by the Morris County Department of Homeland Security to receive a grant for the purchase a License Plate Reader (LPR). The LPR will be installed in the un-marked Traffic Safety patrol vehicle. Lastly, Mr. Williams reported that a training drill is being held tonight at the Chatham Middle School oval with crews from the State Police Northstar helicopter and first responders in the Borough. The oval at the Chatham Middle School has been designated as a new helicopter landing area.

ORDINANCE FOR FIRST READING

Mayor Harris asked Council Member Collander to introduce Ordinance #18-09.

Council Member Collander introduced Ordinance #18-09 by title as follows:

ORDINANCE #18-09

ORDINANCE OF THE MAYOR AND COUNCIL OF THE BOROUGH OF CHATHAM, COUNTY OF MORRIS, NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER 199, PEDDLERS, SOLICITORS AND CANVASSERS

Council Member Collander explained that the purpose of this Ordinance is to amend and supplement Chapter 199, Peddlers, Solicitors and Canvassers, of the Borough Code to balance the First Amendment free speech protections afforded to door-to-door peddling, solicitation and canvassing with the Borough's public safety concerns and the privacy interests of Borough residents.

Council Member Collander read:

WHEREAS, the above Ordinance was introduced and read by title at this Council meeting held on June 25, 2018.

BE IT RESOLVED, that at the Council meeting to be held on July 9, 2018 at 7:30 p.m. prevailing time, at Borough Hall, the Chatham Borough Council will further consider this Ordinance for a second reading, public hearing and final passage; and
