February 22, 2021 MINUTES

Mayor Thaddeus J. Kobylarz called the February 22, 2021 virtual Regular Meeting of the Borough of Chatham to order on Monday, February 22, 2021 at 6:01 p.m. in the Council Chambers in Borough Hall, 54 Fairmount Avenue, Chatham, New Jersey.

SALUTE TO FLAG

Mayor Kobylarz and the Borough Council led the assembled in the Pledge of Allegiance.

Mayor Kobylarz asked for a moment of silence for those who have given their lives for our country. He also gave recognition to those protecting our lives during the current health pandemic caused by coronavirus, COVID-19. He further acknowledged the 28.7 million Americans who contracted COVID-19, and the more than 500,000 people who have died from the disease; and the ten (10) Chatham Borough residents who have died since the pandemic.

WHEREAS, the Mayor's Wellness Advisory Committee recognizes that food is the substance by which life is sustained and the type, quality, and amount of food that individuals consume each day plays a vital role in their overall health and physical fitness; and

WHEREAS, there is a need for continuing nutrition education and a wide-scale effort to encourage healthy eating practices.

Council Member Resto moved to approve Resolution # 21-120, seconded by Council Member Mathiasen. By a unanimous voice vote, Resolution # 21-120 was approved.

DISCUSSION ITEMS

<u>Chatham SEPAG (Special Education Parent Advisory Group):</u>

Presented By: Bonnie Press and Aimee Reali

Council President Dempsey and Council Member Treloar introduced Bonnie Press and Aimee Reali who both gave brief histories of themselves and how they became involved in the, Special Education Parent Advisory Group (SEPAG).

Formally known as CHASE, SEPAG was established in 1998. The program is mandated to be implemented by the Board of Education for students with disabilities. 1 in 5 students are likely to be classified as a child with special needs. Ms. Press discussed the biggest challenges of the program.

Mayor Kobylarz stated that stigmatization is a significant reason that prevents families from reaching out for assistance. He, too, has family members who are diagnosed with ADHD but are high functioning. Ms. Press explained that there is no correlation between people with special needs and low academic abilities, as they are on different trajectories. However, stigmatization is often based on false presumptions. If one admits to special needs assistance, it changes other's perception of them. The learning process is complex, and stigmatization is widespread throughout the country. As per Council Member Resto, children with special needs whose second language is English may experience greater challenges.

Aimee Reali spoke about her experience with her daughter who suffers from dyscalculia and how she was introduced to SEPAG. She explained that most parents realize at a late stage that their child suffers from a learning disability. Diagnosis typically happens between the 4th and 8th grade. She stressed that early diagnosis or detection can make a positive impact.

SEPAG is advocating for the following:

- <u>Increasing Teacher Knowledge Base</u>: Offer full certification to teachers based on the science of reading, using Wilson Certified.
- <u>Improving Data-Based Decision Making</u>: Request data audit to evaluate assessment practices in the classroom and in the evaluation process. Look at tiered support in terms of NJDOE.
- Dyslexia Task Force: Partner with parents and teachers to solve problems.

Ms. Reali discussed the group's goals, priorities, and initiatives. She further stated that children with learning differences are often highly creative and successful in areas of the arts, music, business, mathematics, design, and finance, to name a few. However, during this existential pandemic, many children are struggling to learn. The change to virtual learning is more challenging for those with learning disabilities. COVID-19 has created a significant learning loss in many school-aged children. Forty percent (40%) of first graders are significantly behind in literacy skills. Data has further shown an increase of students scoring below grade level (by 27-40%) since COVID-19.

Members of the Governing Body each commented and thanked the group for the informative presentation and the outstanding efforts and resources available for those in need.

MAYOR'S REPORT I:

Mayor Kobylarz delivered a portion of his Mayor's Report as follows:

Statistical Update on the Coronavirus:

Mayor Kobylarz reported that 402 residents of the Borough have thus far contracted COVID-19. Last week the Borough saw nine (9) new cases. The daily infection rate has plateaued, but the fluctuation has been considerable. New Jersey is trending in a gradual downslope direction, with the current 7-day rolling average of positive cases being 2,711. Last week, it was 3,000. The transmission rate is now 0.91, which indicates we are progressing in the right direction. However, new variants of the virus may complicate the pandemic. He encouraged residents to get vaccinated to reduce the rapid spread of the virus. As per Health Officer Megan Avallone, New Jersey is now exceeding expectations by vaccinating 1.5 million people per day.

However, with the new variants, the infection rates can increase. Therefore, it is vital to remain vigilant. As a community, to mitigate the spread of the virus, we must adhere to the protective measures of washing hands, maintaining social distance, wearing masks, cooperating with contact tracing, and getting vaccinated when authorized by a physician.

COVID-19 Remembrance Service

The COVID-19 Remembrance Service held last night was deeply moving. The number of people who succumbed to the virus is immensely difficult to comprehend. However, we hope that last night's service will help with the healing process. Mayor Kobylarz thanked the weekly Mayors Roundtable participants. He also thanked the President of the Library of the Chathams, Karen Brodsky and Director Andy Hollander. He further acknowledged Chatham Police Chief Brian Gibbons and Police Sergeant Wayne Shivers, and DPW Director Tony Torello and his staff.

Chatham Chinese Association and the Library of the Chathams:

Mayor Kobylarz acknowledged the Chinese New Year celebration in Chatham Borough. The event was organized and well structured. He thanked the organizers for a wonderful event.

Which Ordinance was introduced and passed on first reading at a regular Council meeting held on February 8, 2021.

Mayor Kobylarz asked the Borough Clerk to give a summary of the legal notice.

The Borough Clerk stated a legal notice was published indicating that Ordinance # 21-04 was introduced and passed on first reading at the February 8, 2021 meeting and indicated the second reading and public hearing would be held at 6:00 p.m. on February 22, 2021 for consideration of final adoption. Copies of this Ordinance were made available to the general public and posted in accordance with the law.

Mayor Kobylarz opened the meeting for a public hearing on the Ordinance and any member of the public may be heard.

Seeing no one wishing to be heard, Mayor Kobylarz closed the public hearing.

Mayor Kobylarz proceeded to the Reports from the Borough Council Members.

REPORTS

COUNCIL MEMBERS

Council President Dempsey – Council President Dempsey reported that Chatham Borough representative Michael Valenti had resigned from the Board of Education. The Board will vote on a replacement on March 1, 2021.

Council Member Mathiasen created a survey for residents pertaining to recreational facilities within the Borough to obtain feedback on what residents would like to see within the Borough and improvements they recommend.

Council President Dempsey thanked all donors to the food distribution program. There was a record number of people who came to the distribution line on Wednesday.

Morris County's "Navigating Hope" van will return to the Borough on February 24, 2021 at Firehouse Plaza from 12:00 p.m. to 4:00 p.m. "Navigating Hope" moves around the county to reach and inform the public about different long and short-term assistance programs available to the public (e.g. cash assistance, housing assistance, utilities etc.). Residents were encouraged to take advantage of the available services.

Council Member Mathiasen – Council Member Mathiasen reported that the Budget & Finance Committee met and discussed the short-term financial struggles ahead with respect to the Borough's budget. Increases in healthcare and mandated changes in retirement plans among other things have created a budget challenge. The loss of revenue in certain areas due to the pandemic, such as parking, also contributed to the financial challenge. However, the Borough remains fiscally strong. The Budget & Finance Committee will meet and discuss the budget of each department. The public is encouraged to attend the budget hearing when it is held to understand the dynamics of the Borough's municipal budget.

Council Member Treloar – Council Member Treloar reported that the MyChathamNJ Advisory Committee met on Friday, February 19, 2021. The committee wants to remind residents that the Annual Spring-Cleaning date is on the Borough's calendar and anyone wishing to volunteer should contact Community Services.

Council Member Koronkiewicz – Council Member Koronkiewicz had nothing new to report.

Council Member Resto – Council Member Resto reported on the food distribution program at the Chatham United Methodist Church. He thanked everyone for coming together to facilitate in helping our neighbors. There was a record number of vehicles that showed up for assistance, 63 vehicles. Some vehicles had to collect for others. Seven (7) vehicles were new, and several families

stated they have exhausted their savings, while others expressed embarrassment in obtaining assistance.

The Board of Health met on February 11, 2021. Kay Kaiser was appointed President and Robert Weber was appointed Vice President. Anyone interested in joining the Board of Health should contact him for information on how to volunteer.

The Undergrounding Advisory Committee is working on forming a working group of municipalities with JCP&L. The BPU ordered JCP&L to begin studying undergrounding wiring, especially in high-risk areas.

Lastly, the Senior Citizen Advisory Committee will propose ideas for consideration by the Mayor and Council and potentially conduct Town Hall meetings to permit senior residents to voice their concerns.

Council Member Truilo – Council Member Truilo reported that the Historic Preservation Commission met and nominated John and Marie Perry of 12 Washington Avenue for its Flag Award. The Perry family were delighted to receive this nomination.

Council Member Truilo further reported that the Planning Board approved a hot yoga studio on N. Passaic Avenue.

MAYOR'S REPORT II

Mayor Kobylarz had nothing further to report.

ADMINISTRATOR'S REPORT

Business Administrator Steven Williams reported as follows:

- Mr. Williams asked residents to keep sidewalks clear, and for properties with a fire hydrant to clear a 3-foot perimeter around the hydrant to ensure it is clear of snow in the event of an emergency.
- PSE&G will begin construction in March to replace the old high-tension towers in the Borough.
- Residents were encouraged to visit the Borough's website and register with the Borough's Constant Contact List.

WHEREAS, the Borough of Chatham, County of Morris, State of New Jersey recognizes that the abuse of alcohol and drugs is a serious problem across all communities in our society and amongst people of all ages; and

WHEREAS, the Borough of Chatham further recognizes that it is incumbent upon not only public officials but upon the entire community to take action to prevent such abuses in our community; and,

WHEREAS, the Borough of Chatham and the Township of Chatham have combined efforts and established the Municipal Alliance Committee of the Chathams; and,

WHEREAS, the Municipal Alliance Committee of the Chathams was approved for Municipal Alliance grant funding for the previous Grant Year October 2020 - June 2021; and

WHEREAS, the Governor's Council on Alcoholism and Drug Abuse has agreed to make a \$6,035.00 grant fund allocation available to the Municipal Alliance Committee of the Chathams for Grant Year October 2020 - June 2021, contingent upon meeting the Municipal Alliance Committee of the Chathams contribution of 25% Cash Match (\$1,508.75) and a 75% In-Kind Match (\$4,526.25) for a total Budget of \$12,070.00; and
