# **SALUTE TO FLAG**

Mayor Kobylarz and the Borough Council led the assembled in the Pledge of Allegiance.

Mayor Kobylarz asked for a moment of silence for those who have given their lives for our country. He also gave recognition to those protecting our lives during the current health pandemic caused by coronavirus, COVID-19. He further acknowledged the 31.2 million Americans who contracted COVID-19, and the more than 562,000 people who have succumbed to the virus. Finally, he acknowledged the ten (10) Chatham Borough residents who have died since the pandemic.

# RESOLUTION TO EMPLOY JOHN P. GRAZIANO AS A PROBATIONARY POLICE OFFICER FOR THE BOROUGH OF CHATHAM POLICE DEPARTMENT

**WHEREAS**, the Borough of Chatham publicly advertised the job opening for the position of a police officer and solicited resumes and applications from interested candidates; and

**WHEREAS**, the selection committee (the "Committee") conducted interviews of interested and qualified candidates; and

**WHEREAS**, after considering all interested and qualified candidates, the Committee found that John P. Graziano is the best-qualified candidate and has recommended that he be hired for the police officer position.

**BE IT RESOLVED**, by the Mayor and Council of the Borough of Chatham that they concur with the recommendation of the Committee and hereby authorize John P. Graziano to be appointed as a Probationary Police Officer at a salary of \$52,466.54 effective April 13, 2021, to be prorated for the remainder of 2021; and

**BE IT FURTHER RESOLVED**, that the Chief of Police is authorized to undertake and execute such employment documents as are necessary to implement this resolution.

Council Member Koronkiewicz moved to approve Resolution # 21-154, seconded by Council Member Resto. By a unanimous voice vote, Resolution # 21-154 was approved.

### ADMINISTRATION OF OATH: OFFICER JOHN P. GRAZIANO

Borough Clerk Tamar Lawful proceeded to administer the oath of office to Officer John P. Graziano. Upon administration of the oath, Chief Gibbons acknowledged the family of Officer Graziano, all of whom attended virtually. He further gave a brief history of the newly appointed officer.

## **DISCUSSION ITEMS**

# **Introducing Stanley Center:**

Presented By: Council President Dempsey and Council Member Mathiasen

Council President Dempsey and Council Member Mathiasen gave a presentation on the Stanley Congregational Church which was donated to the Borough. Council President Dempsey provided a brief history of the property. She further explained the process that led to the Borough's acquisition of the church. A virtual tour of the building was demonstrated by Council President Dempsey and Council Member Mathiasen. The tour showed the interior of the building and the many exquisite rooms which can be utilized by the public. Ideas of how to use the building were proposed during the virtual tour. For instance, the property can be used for weddings, concerts, and shows, or an office space. There are numerous uses for the building. Both Council Members went room by room revealing the well-kept property.

An application was submitted to the New Jersey Historic Preservation Office and the National Register of Historic Places to register the property as a historic building. As a historic building, the Borough will have the opportunity to apply for grants to assist with maintenance of the property. A survey will be created to allow residents to provide feedback and ideas on how the property could be utilized. The Borough will meet with various recreational centers to ensure the building is utilized in the best way, and with the best revenue options possible.

# **Recreation Facilities Survey Results:**

Presented By: Council President Dempsey and Council Member Mathiasen

Council President Dempsey and Council Member Mathiasen presented on the recreational survey results. It was reported that an overwhelming number of votes went towards the refurbishment of the basketball courts, followed by the tennis courts. The Budget and Finance Committee allocated \$150,000 towards the improvement of parks. The improvements include the basketball courts, the enclosed dog off-leash area at Shepard Kollock Park, and the tennis courts. Residents were encouraged to submit a survey and provide their input on desired recreational improvements in the Borough.

## **MAYOR'S REPORT I:**

Mayor Kobylarz delivered a portion of his Mayor's Report as follows:

# Statistical Update on the Coronavirus:

Mayor Kobylarz reported that 446 residents of the Borough contracted COVID-19 since the start of the pandemic. Last week, the Borough had nine (9) new cases. New Jersey is trending in a gradual downslope direction, with the current 7-day rolling average of 3,173 positive cases. Last week, it was 3,349. The transmission rate is now 0.94, which demonstrates progress. Health Officer Megan Avallone advised the public to take precautions. New Jersey remains at high risk per capita compared to other states in the nation.

Mayor Kobylarz cautioned the public to remain vigilant; and to mitigate the spread of the virus by adhering to protective measures of washing hands, maintaining social distance, wearing masks, cooperating with contact tracing, and getting vaccinated.

# New Basketball Court:

As reported by Council President Dempsey and Council Member Mathiasen, Borough residents have expressed interest in seeing a new basketball court. The Borough has already started the improvement of the basketball court and it is projected to be available for the public's use by the end of June 2021. The basketball court is the first tangible project to be addressed from the survey results.

# Chatham Borough Restaurants:

COVID-19 (coronavirus) has created many challenges to the retail industry. For this reason, the Borough wants to assist the downtown businesses and eateries in any way possible. Tonight's agenda lists Resolution # 21-167, which is intended to suspend the outdoor dining application fee for 2021. Additionally, short-term parking zones were made available for outside eateries, and picnic tables have been placed by the gazebo to provide additional dining opportunities for the public wishing to order take-out to be enjoyed outdoors. Outdoor lighting will be installed by the gazebo to enhance the ambiance of the outdoor dining experience. The Mayor intends to meet with restaurants, and review measures that may be of further assistance. There will be a webinar in April to discuss both state and federal funding for small businesses.

# Acknowledgement of Ramadan:

Mayor Kobylarz acknowledged the holy month of worship for the Muslim community. He wished Borough residents a blessed Ramadan.

# **Robert Weber- 99 Summit Avenue:**

Mr. Weber inquired about the new legislation that legalized cannabis in New Jersey. He explained the new law permits municipalities to manage the presence of cannabis establishments in their municipalities. He further explained that municipalities have until August 22, 2021 to act on how cannabis establishments will be managed in their respective towns. Failure to act will restrict a municipality from taking further action relating to this new law for five (5) years.

Mr. Kleinman stated that the Borough is in the process of moving forward shortly on how to regulate the new legalization of cannabis.

## Freddie Bicknese – 137 N. Hillside Avenue:

Mr. Bicknese asked the Council whether they will commit to banning the operation of cannabis businesses in the Borough.

Mr. Kleinman clarified the new law and explained that people may still purchase or use cannabis. The new legislation cannot be outlawed, only regulated. The law permits the manufacture and sale of marijuana. The question is whether the Borough will permit businesses to be operated in the Borough. Council Member Mathiasen added that public spaces can be regulated to ban the use of cannabis.

Seeing no one else wishing to be heard, Mayor Kobylarz closed the meeting to the public.

Mayor Kobylarz proceeded to Borough Council Member Reports.

### **REPORTS**

# **COUNCIL MEMBERS**

**Council President Dempsey** – Council President Dempsey reported that effective April 19, 2021, sixth-graders and high school students will begin in-person learning, Monday – Friday. However, students will be dismissed at lunchtime.

It was further reported that a new Class III Police Officer will be stationed at the Chatham Middle School.

Council Member Mathiasen – Council Member Mathiasen reported that the 2021 Municipal Budget is almost complete. She stated that uncontrolled circumstances surrounding COVID-19 have created financial challenges to the budget. There have been increases in state pension costs, and loss of revenue from parking, and the municipal court. Nonetheless, the Borough remains fiscally strong. The 2021 budget presentation will be conducted by Karen Fornaro on April 26, 2021. She further acknowledged the members of the Budget & Finance Committee for their hard work and efforts during the budget process.

**Council Member Koronkiewicz** – Council Member Koronkiewicz reminded residents to secure a permit to remove any tree in the Borough. The Shade Tree Commission is also responsible for planting new trees. Trees serve many important purposes, including enhancing the appearance of the community which helps increase property values.

**Council Member Treloar** – Council Member Treloar reminded the public of the town-wide garage sale event on April 17, 2021.

She further reported on an upcoming webinar which will discuss the planning stage for the end of life on Wednesday, April 14, 2021.

Lastly, Spring Clean is scheduled on May 1, 2021. For more information, kindly contact Community Services.

**Council Member Resto** – Council Member Resto reported that the Department of Health will have vaccines available for home-bound seniors on Tuesday April 13, 2021.

The Senior Center will be available to provide transportation for seniors with vaccination appointments. The website for booking an appointment was provided.

The Economic Development Advisory Committee created a sub-committee called Student Consultants Aiding the Local Economy (SCALE). The sub-committee will provide services to local businesses by promoting businesses through a greater presence on social media.

Council Member Resto thanked residents for their continuous generosity in supporting the Chatham Food Distribution Program. He reported that 81 hams were received as donations. The hams were donated to the food insecure coming through the Food Distribution line for Easter. Children were given beautifully decorated Easter Baskets for which the Girl Scouts were thanked.

Lastly, the Senior Citizen Advisory Committee will host a paper shredding event on Saturday, April 24, 2021.
