Yana Doyle, 8 Rose Terrace- Spoke in support of eliminating the green plastic bags and commented on bulk pickup.

Rozella Clyde, 33 Carmine St.- Spoke in support of eliminating the green plastic bags and in favor of the automated service.

Allison Slater, 171 Weston Ave. - Spoke in support of eliminating the green plastic bags and voiced her support for the automated service.

Tim Anderson, 52 Hedges Ave. - Requested that residents be charged differently based on the size of the garbage can they will be using.

Val Clark, 21 Fern Ave. – Concerned about bins being left out and that residents will not recycle if the town changes from the green bag system. Not in favor of changing to the automated system.

Jack Drew, 32 Inwood Rd. – Concerned that if the town does away with the green bags residents will no longer recycle and is not in favor of the automated system.

Fran Drew, 32 Inwood Rd.- Would like additional parking in post office plaza instead of affordable housing. Presented the governing body with her idea.

Susan Robertson, 45 Highland Ave. – Spoke in favor of the automated service and getting rid of the green bags as well as promoting recycling in the Borough.

Tim Zagonas, 8 Second St. – Voiced his concern about large trucks passing through the Borough along Second Street and South Passaic Ave. and feels signs are needed to restrict them.

Joseph Treloar, 89 Elmwood Ave. - Feels if the automated service is implemented properly this could be beneficial to this town as well decrease the carbon footprint in town.

WHEREAS, The Borough Purchasing Agent publicly opened bids on July 14, 2022, for Solid Waste Collection Services; and

WHEREAS, the bid for solid waste collection services included several bid options for a five (5) year contract:

- Base Bid: Rear Load Collection Services and continuation of green bag program
- Alternate Option One: Rear Load Collection Services and discontinuation of the green bag program and Borough assumes the tipping fees
- Automated Collection Services and discontinuation of the green bag program and Borough assumes the tipping fees

WHEREAS, one (1) bid was received from Suburban Disposal, Inc. and the bid options are as follows;

WHEREAS, the Borough estimates our current tipping fee to be approximately \$315,000 which was included as an evaluation factor when examining the various bid options; and

WHEREAS, after evaluating all cost factors, the Borough wishes to transition to Alternate Bid Option Two: Automated Collection Services; and

WHEREAS, Suburban Disposal, Inc. is the lowest responsive and responsible bidder and has been duly reviewed and analyzed by the Chatham Borough Attorney and the Qualified Purchasing Agent; and

WHEREAS, the bid received by Suburban Disposal, Inc. has been found to be in proper form and in compliance with the provisions of N.J.S.A. 40A:11-1 et seq and N.J.A.C. 7:26H and the specifications as written; and

WHEREAS, the Chief Financial Officer has certified that encumbrances for these services shall come from account number 2-07-55-502-233 and will be appropriated in future years' budgets.

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Chatham, County of Morris, State of New Jersey, as follows:

- 1. The Borough Council hereby awards a contract to Suburban Disposal, Inc. of Fairfield, New Jersey in the following manner to allow transition time to the automated collection services option:
 - Effective April 1, 2023 through December 31, 2023: Base Bid Option Rear Load Collection, two times per week, continuation of green bag program and contractor assumes all tipping fees to be paid in monthly installments of \$49,333.33
 - Effective January 1, 2024 December 31, 2024: Alternate Bid Option Two Automated Collection one time per week, discontinue green bag program, Borough assumes all tipping fees and Borough provides all residents with trash bin to be paid in monthly installments \$36,583.33
 - Effective January 1, 2025 December 31, 2025: Alternate Bid Option Two Automated Collection one time per week, discontinue green bag program, Borough assumes all tipping fees and Borough provides all residents with trash bin to be paid in monthly installments \$38,083,33
 - Effective January 1, 2026 December 31, 2026: Alternate Bid Option Two Automated Collection one time per week, discontinue green bag program, Borough assumes all tipping fees and Borough provides all residents with trash bin to be paid in monthly installments \$40,333.33
 - Effective January 1, 2027 March 31, 2028: Alternate Bid Option Two Automated Collection one time per week, discontinue green bag program, Borough assumes all tipping fees and Borough provides all residents with trash bin to be paid in monthly installments \$43,166.66
- 2. The Mayor and Borough Clerk are hereby authorized and directed to execute a contract with Suburban Disposal, Inc. in accordance with its bid for Solid Waste Collection Services.

RESOLUTION OF INTENT TO BOND TO APPROPRIATE FUNDS OR BOND IN THE EVENT OF A FUNDING SHORTFALL FOR THE BCUW 15-UNIT 100% AFFORDABLE FAMILY RENTAL HOUSING PROJECT

WHEREAS, the Borough of Chatham (the "Borough") has proposed a municipally sponsored 15-unit 100% affordable family rental housing project (the "Project") to be constructed and operated by BCUW / Madeline Housing Partners LLC ("BCUW") on Borough-owned land, Lot 10 in Block 121, in the southeast corner along Bowers Lane as a mechanism for the redevelopment of Post Office Plaza redevelopment area and has entered into a Redevelopment Agreement with BCUW dated September 16, 2022 (the "Redevelopment Agreement") for that purpose; and,

WHEREAS, section 4.2 of the Redevelopment Agreement provides that BCUW will seek funding for the Project from various sources and, to the extent there is a shortfall in such funding, the Borough shall provide funding, first from its Affordable Housing Trust Fund, and second from other Borough sources of funds; and,

WHEREAS, by adoption of Ordinance #22-12 on October 11, 2022, the Borough appropriated the sum of \$6,000,000 and authorized the issuance of bonds to finance the costs of construction of the Project to the extent of a shortfall in funding; and,

WHEREAS, the Borough is currently seeking court approval in its pending declaratory judgment action titled <u>I/M/O the Borough of Chatham Mount Laurel Compliance</u>, Docket No. MRS-L-1906-15, for the approval of the BCUW Project as part of its affordable housing plan as a substitute mechanism pursuant to a June 14, 2021 First Amendment (the "First Amendment") to the November 7, 2016 Settlement Agreement it entered into with Fair Share Housing Center

("FSHC") to replace 15 units of affordable housing that would have been generated by an inclusionary development in the Post Office Plaza redevelopment area, and FSHC has objected to the court approving the BCUW Project on a number of grounds, with one of the grounds being its concern regarding the timing of the construction of the Project in the event that a funding shortfall in excess of \$6,000,000 is experienced; and,

WHEREAS, the Borough has come up with a solution to that objection which is to adopt a Resolution of Intent to Bond for any such additional shortfall, using the form of Resolution of Intent to Bond developed by the Council on Affordable Housing ("COAH") in 2008 (during the third-housing round), and which would also include a "trigger" date for the Borough to request note financing authorized by Ordinance #22-12 tied to the Project financing dates contained in the Preliminary Development Project Timeline which is attached to and incorporated into the Redevelopment Agreement as Exhibit B-3, with the goal being to ensure that the Project is constructed with certificate(s) of occupancy granted by March, 2025 and no later than June 30, 2025, just prior to the end of the third-round of affordable housing; and,

NOW, THEREFORE, BE IT RESOLVED by the Governing Body of the Borough of Chatham, Morris County, State of New Jersey, that the Governing Body does hereby agree to appropriate funds and authorize debt to fund any shortfall over the \$6,000,000 already authorized for the construction of the Project that may arise whether due to inadequate funding from other sources or for any other reason; and

BE IT FURTHER RESOLVED that, upon notification that inadequate funding exists for the construction of the Project, the Borough of Chatham agrees to appropriate funds and authorize debt to fund any shortfall over the \$6,000,000 already authorized for the construction of the Project within 90 days of such notification; and

BE IT FURTHER RESOLVED that the Borough of Chatham may repay debt through future collections of development fees, as such funds become available; and

BE IT FURTHER RESOLVED that the Borough of Chatham will request note financing authorized by Ordinance #22-12 no later than January, 2024 if BCUW's funding sources have not provided the amount of money BCUW needs to construct the Project as January, 2024 is the outside date for BCUW to obtain funding from sources other than the Borough and construction is slated to commence in March, 2024 and to be completed with certificate(s) of occupancy obtained by March, 2025, with the fourth-round of affordable housing to begin in July, 2025.

AN ORDINANCE OF THE MAYOR AND BOROUGH COUNCIL OF THE BOROUGH OF CHATHAM IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY AMENDING AND SUPPLEMENTING CHAPTER 79, ENTITLED "ANIMAL AND RABIES CONTROL" OF SECTION 16 THEREOF ENTITLED "FEES"

WHEREAS, Chapter 79, entitled "Animal and Rabies Control", of the Borough Code regulates the enforcement and fees charged pursuant to the Borough's General Legislative Code in the Borough of Chatham; and

WHEREAS, it has been recommended that Chapter 79 entitled "Animal and Rabies Control" be amended and supplemented in Section 16 entitled "Fees".

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Council of Chatham Borough, in the County of Morris, State of New Jersey, as follows:

Section 1.

Chapter 79 of the Code of the Borough of Chatham, Section 16 thereof, entitled "Fees" is hereby amended as follows:

"The following fees shall be paid to the Borough of Chatham for compliance of this chapter:

B. Late charge for dog or cat license and registration tag, effective February 1: \$10.00

Section 2.

All other provisions of Chapter 79 not amended or replaced herein remain in full force and effect.

Section 3.

If any section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

Section 4.

All Ordinances or parts of Ordinances of Chatham Borough inconsistent herewith are repealed to the extent of such inconsistency.

Section 5.

This law shall take effect immediately upon final passage, approval and publication as required by law.

WHEREAS, this Ordinance was introduced and read by title at a meeting of the Council for the Borough of Chatham (the "Council") held on October 24, 2022; and

WHEREAS, by Ordinance No. 19-10 adopted April 22, 2019, the Mayor and Council adopted the Post Office Plaza Redevelopment Plan (the "Plan"); and

WHEREAS, by Ordinance 21-22 adopted December 13, 2021, the Plan was amended; and

WHEREAS, by Resolution 22-169 adopted by the Mayor and Council May 2, 2022, the Mayor and Council determined that the affordable housing requirement for the Post Office Plaza Redevelopment Area would be achieved by a 15-unit residential structure to be located on Lot 10 in Block 121, in the Southeast corner along Bowers Lane; and

WHEREAS, the Mayor and Council directed the Borough's Affordable Housing Planning consultant, Kendra A. Lelie of TM Associates (the "Planner") to prepare an amendment to the redevelopment plan to restate the redevelopment plan to solely address the affordable housing structure; and

WHEREAS, the Planner prepared a Restated Redevelopment Plan dated September 8, 2022, (the "Restated Plan"), which shall extend only to Lots 10 and 17 in Block 121 as shown on the Tax Assessment Map of the Borough of Chatham (the "Tax Map"); and

WHEREAS, the Mayor and Council desire to confirm that the Zoning for the balance of the Post Office Plaza Redevelopment Area, not affected by the Restated Plan, shall revert to the zoning in place prior to the adoption of Ordinance 19-10; and

WHEREAS, by Ordinance 22-11 adopted October 11, 2022, the Mayor and Council confirmed the reversion of prior zoning; and

WHEREAS, Ordinance 22-11 contains an error in Section 1 in the identification of Lot 10 (part of) in Block 121 and the identification of Lot 1 in Block 122, and Section 2, in the identification of Lot 1 in Block 122, and a typographic error in Section 7 which errors shall be corrected by the adoption this Ordinance; and

WHEREAS, pursuant to N.J.S.A. 40:55D-26, the Council will refer this Ordinance to the Planning Board of the Borough of Chatham (the "Board") for a report as to which provision of this Ordinance, of any, may be inconsistent with the Master Plan of the Borough of Chatham, and any other recommendations the Board may have; and

WHEREAS, assuming that the Board considers this Ordinance at a public meeting held on November 2, 2022 and issues a report prior to November 14, 2022, the Council has scheduled this Ordinance for a public hearing for adoption for November 14, 2022; and

NOW THEREFORE, BE IT RESOLVED by the Council of the Borough of Chatham as follows:

SECTION 1

Lots 10 (part of), 11, 12 and 13 in Block 121 and Lot 1 in Block 122, as shown on the Tax Map are restored to and shall hereafter be located in the B-4 Community Business District as set forth in Section 165-19 of the Borough Ordinances.

SECTION 2

Lots 13, 14 and 15, 16, 17 and 18 in Block 122 as shown on the Tax Map are restored to and shall hereafter be located in the AFD-4 Affordable Housing District as set forth in Sections165-39-45 of the Borough Ordinances.

SECTION 3

Lot 2 in Block 122, as shown on the Tax Map are restored to and shall hereafter be located in the B-3 General Business District as set forth in Section 165-18 of the Borough Ordinances.

SECTION 4

Borough of Chatham, Zoning Map shall be amended to show the revisions as set forth in Sections 1, 2, and 3 of this Ordinance.

SECTION 5

If any Sections, Subsections, paragraphs, sentence or any part of this Ordinance is judged unconstitutional or invalid, such judgment shall not effect, impair or invalidate the remainder of this Ordinance.

SECTON 6

All Ordinances or parts of Ordinances that are inconsistent with the provisions of this Ordinance are hereby repealed to the extent that such inconsistencies.

SECTION 7

This Ordinance shall take effect after: (1) final passage and publication as prescribed by law; (2) filing with the Morris County Planning Board; and (3) entry of an amended judgment of compliance and repose in the pending affordable housing declaratory judgment action titled Laurel Affordable Housing Obligations, Docket No. MRS-L1906-15, which amended judgment shall recognize the elimination of the following lots from the Post Office Plaza Redevelopment Plan, which lots will have their prior zoning designations restored pursuant to this ordinance: (a) Lots 10 (part of), 11, 12 and 13 in Block 121, and Lot 1 in Block 122 as shown on the Tax Map, which will be restored to and be located in the B-4 Community Business District as set forth in Section 165-19 of the Borough Ordinances; (b) Lots 13, 14 and 15, 16, 17 and 18 in Block 122, as shown on the Tax Map, which will be restored to and be located in the AFD-4 Affordable Housing District as set forth in Sections165-39-45 of the Borough Ordinances and (c) Lot 2 in Block 122, as shown on the Tax Map, which will be restored to and be located in in the B-3 General Business District as set forth in Section 165-18 of the Borough Ordinances.
