#### **Public Comment**

Rozella Clyde, 33 Carmine St., asked where could she obtain the details for Resolutions 2017-23 and 2017-24.

Chrmn. Favate and Attorney Loughlin noted that the hearings for these resolutions have been concluded. The resolutions are a summary of the testimony heard by the Board on these applications. Attorney Loughlin stated that a copy of the application could be obtained at the Zoning Board Secretary's Office. Also, there are recordings are made of these hearings.

Mrs. Clyde asked whether it was an appropriate time to make a comment on Resolution 17-288.

Chrmn. Favate answered that Mrs. Clyde could make her comments when the Board reached that resolution.

#### Resolution #PB 2017-22

Vice Chrmn. Wagner made a motion to approve the Planning Board minutes from the September 6, 2017 meeting as submitted. Mr. Williams seconded the motion. The minutes were approved as submitted.

#### **Discussion Items**

Resolutions

Resolution #PB-2017-23: A resolution authorizing the Planning Board of the Borough of Chatham to undertake a preliminary investigation to determine if certain real property within the Borough of Chatham are areas in need of redevelopment.

Mayor Harris recused himself from this discussion and left the room.

Attorney Loughlin noted that the Planning Board received a redevelopment study and investigation to be undertaken for the Mayor and Borough Council. The Board commissioned a report. A public hearing was held on the report. The Board then made a recommendation to the Mayor and Borough Council. Subsequently, the Mayor and Borough Council enacted a resolution adopting the recommendations, except for one lot. Since then, the Mayor and Borough Council have referred back to the Board. However, last month it was determined by the Special Redevelopment Court that Council Member Fife had a conflict of interest, and that as a result of her conflict, so did Mayor Harris, so the approval process needs to be restarted.

Attorney Loughlin stated that the Mayor and Borough Council have rescinded their redevelopment resolution. As a result of this action, the Mayor and Borough Council have referred this matter back to the Planning Board to re-start things.

Attorney Loughlin explained the two resolutions he had before the Board tonight. One resolution acknowledges that this matter has been returned to the Planning Board and the rescinding of this matter. The second resolution is from the Mayor and Borough Council, asking the Planning Board to recommence an investigation and study for the properties in question, listed on tonight's agenda. An expert would be retained to prepare a new study.

Chrmn. Favate noted that Resolution #PB-2017-23 would rescind the Board's prior resolution that approved the Redevelopment Study Area.

Vice Chrmn. Wagner made a motion to approve Resolution #PB-2017-23. Mr. Montague seconded the motion.

Rozella Clyde, 33 Carmine St., asked what was the exact title of the statute that governs this matter.

Attorney Loughlin answered the Redevelopment Statute. He explained to Mrs. Clyde where it could be found. He informed Mrs. Clyde that, at this point, the Board is not permitted to discuss anything about the area in question and its possible uses. This is not a public hearing. A dialogue with the Board on this matter cannot be held tonight.

Mrs. Clyde asked when will a public hearing be held on this matter.

Attorney Loughlin answered that after the study is done, a date for the hearing will be published twice in the newspaper, and announced on the Borough website. Parties involved in the designated area will have to be notified.

Mrs. Clyde asked that once the procedural process is completed, will the information be presented on the Borough website?

Attorney Loughlin answered yes.

Mrs. Clyde said she would like some type of time-frame for this process.

Attorney Loughlin explained that a schedule of hearings will be established once the consultant's report is done and submitted to the Board. Chrmn. Favate recommended that Mrs. Clyde keep an eye on the Borough website for future activities on this matter.

There were no further questions from the public.

A roll call vote was taken on the motion approving Resolution #PB-2017-23:
