Surveillance Camera Registration

If you currently utilize private video surveillance at your home or business, The Chatham Borough Police Department would like to hear from you. Video surveillance is an effective method for identifying criminals and investigating suspects who are caught in the act of committing a crime. Installing and registering a video surveillance system is a great example of community-police partnerships, which is something we highly value as a police agency serving our community.

The Chatham Borough Police Department is committed to our partnership with the residents and business owners in our community. Many business owners and residents currently operate private surveillance systems at their businesses and or homes. When crimes and other incidents occur nearby, they are not always aware that their system may have captured pertinent information that could help facilitate our investigation, thus keeping our community safer. We are asking that residents and business owners across the borough register their privately owned surveillance camera systems with the Chatham Borough Police Department. As we investigate crimes and incidents, we may be able to use the information or footage gathered from your system to assist in the identification, apprehension and prosecution of the criminals involved. After registering your camera, you would only be contacted by the Chatham Borough Police Department if there is a criminal incident in the vicinity of your security system. Police personnel, if necessary, may request to view your footage in order to assist in the investigation. Help us make Chatham Borough an undesirable place for criminals to commit crimes and help keep your entire community safe!

Registration is voluntary and there is no cost associated. Registering your information does not provide the Chatham Borough Police Department with direct access to your camera. You may withdraw your registration at any time. An individual's personal information will be kept confidential by this Agency unless subject to disclosure by court order. Your information will be accessed by law enforcement personnel who are investigating a crime in the vicinity of where your camera is located. You will only be contacted by the Chatham Borough Police Department in the future if there is a criminal incident in the vicinity of your security camera. Police personnel, if necessary, may request a copy of any video captured by your camera, which may assist in the investigation of a crime.
