GUIDELINES FOR APPLYING FOR BOROUGH BOARDS, COMMISSIONS AND/OR ADVISORY COMMITTEES PURSUANT TO CHAPTER 3 OF THE CODE OF THE BOROUGH OF THE CHATHAM ENTITLED “APPOINTED POSITIONS REGISTRY”

- Please submit one (1) Volunteer Application per board, commission or committee for which you are applying. Applications are kept on file for two (2) years.
- An electronic signature is acceptable for the purpose of deeming the application complete.
- The Borough Clerk will respond and acknowledge receipt of the Volunteer Application Form on or before seven (7) days after the receipt.
- Borough of Chatham employees may not serve on Borough of Chatham boards or commissions except as specifically provided by the statute or regulation, or by the Borough Code, as required to perform official duties.
- **IN ACCORDANCE WITH THE STATE ETHICS LAW, [N.J.S.A.52:13D-12](#) AND THE LOCAL GOVERNMENT ETHICS LAW, [N.J.S.A. 40A:9-22.6](#)**, a Financial Disclosure Statement is required to be filled annually by (i) elected officials; (ii) certain government employees; and (iii) individuals serving on a local government agency which have the authority to levy taxes, enact ordinances, approve development applications or grant zoning variances. The Borough Clerk will notify such individuals each year when their Financial Disclosure Statement must be completed and filed with the State of New Jersey.
