Lisa DeRosa Motioned to approve; Kay Kaiser seconded the motion. Approved minutes shall be filed as a permanent record in the Borough Clerk's office.

#### **REPORTS:**

## 1. Animal Control Report

Mr. Weber questioned the return of a possible poisonous snake to where it was found. Megan Avallone explained that certain snakes such as the Copperhead snake is a protected species.

2. BOH Vital Statistics Report was reviewed.

#### **DISCUSSION ITEM(S)**

- 1. Coronavirus update
- Megan Avallone spoke to the current statistics and gave a brief overview regarding COVID-19 and testing. Cases are on the decline, at 14% positivity compared to 60% at the height of the pandemic.
- She discussed the reopening of the Borough and the State as a whole following the CDC Guidelines. Pools have been instructed to prepare, so that if they get the go ahead they can move ahead quickly.
- She explained how there are several levels of illness, it not either you recover or pass away; there is an issue of complications of being sick for weeks including permanent organ damage.
- Contact Tracing; the Westfield HD has been connecting people to social services in addition to working extensively on contact tracing.
- Shell Lee and Lara Freidenfelds stated they have both signed up to become contact tracers through the state. Lara said they will keep in touch regarding the program.

- Lisa DeRosa mentioned that she has noticed many kids gathering at local parks and on Main Street; Mayor Kobylarz said that the Executive Orders are still in effect, including the stay at home order and social distancing guidelines.
- He suggested a press release come from the Board of Health regarding the guidelines being followed.
- Lisa DeRosa suggested the COVID task force do all that on real time messaging. Mayor Kobylarz said he would discuss the statement with Megan Avallone.
- Lara Freidenfelds stated that it is middle schoolers that have been in large groups, and that the statement may not be received favorably.
- Discussion continued about suggestions for the message on the guideline.
- 2. Flu activity fall clinic.
- It was proposed to do a flu clinic mid-September. The clinic is not included in the current contract, but the cost would only be for purchasing the vaccine itself not for staff time.
- Megan Avallone said this year is expected to be a high vaccination year. Discussion

Bob Weber broached the subject of the community pool; should we open it? Megan Avallone suggested lowering capacity, utilizing resources and waiting for the Governor's EO to work together to see if it is feasible.

Lara Freidenfelds has volunteered along with Andrew Zoltan to produce a statement on gatherings which will be reviewed by the Mayor and the Borough Attorney prior to distribution.
