- 1. Introduced Board of Health ordinances were discussed. An Amendment will be added to Ordinance 2020-06 to alleviate the inconsistency between the new policy and the previous Ordinance regarding composting.
- 2. Megan Avallone discussed the outcome of NJ S2173; Lawmakers failed to get enough votes to pass the bill that would have removed religious exemptions from children needing vaccinations to attend school. Discussion about the bill's outcome followed; the bill will be reintroduced at a later date.
- 3. Coronavirus update: the Westfield Regional Health Department is working with the NJ Department of Health to monitor the situation closely and is proactively preparing guidance documents for health care professionals to be able to effectively respond to any cases that may be identified in the state. As of today, there are no reported cases in New Jersey.
- 4. Flu activity update Megan Avallone discussed the status of the Flu outbreak at a Chatham Nursing Home, which was contained due to the staff's quick and outstanding response.
- 5. Mrs. Bringgaard advised the members of the Board the MACC is looking for a new Coordinator for the Program.
