The Regular Council Meeting of the Borough of Chatham was held on Monday January 28, 2013 beginning at 7:30 p.m. in the Council Chambers, in the Municipal Building.

The meeting was called to order at 7:30 p.m.; Mayor Bruce A. Harris presiding.

Mayor Harris asked for a moment of silence for those people who have given their life for this country, for Stan Serbanica's father who passed away recently and for Janice Piccolo's father who passed away over the weekend, and for Stanley Brown, husband of former Council Member, Freeholder and State Senator Leanna Brown.

Reorganization Meeting, January 7, 2013 Regular Council Meeting, January 7, 2013

Council Member Holman read and moved Resolution #13-98, seconded by Council Member Collander. A vote was taken and it was approved unanimously.

Mayor Harris wished Council President Resto a Happy Birthday.

DISCUSSION ITEMS

<u>Preliminary 2013 Budget</u>- Mr. Lonergan explained the challenges from last year's budget. The challenges will be similar for the 2013 budget. Hurricane Sandy and the Tricare litigation will have a big impact on the budget. Mr. Lonergan stated the committee is looking at a 1.5% to 2.5% increase in property taxes as part of the budget. A full budget presentation will be made at the February 25th Council Meeting.

<u>2013 Sewer Rate Fee-</u> Mr. Lonergan stated the water/sewer rates will increase 2% for 2013. The rate will go from \$3.45 to \$3.47.

Mayor Harris thanked Council Member Collander, TSO Sweetin, the Police Department, Chief Crosson, Lieutenant Gibbons, Council Member Fife and Council Member Helfrich for their work on the Long Range Traffic and Pedestrian Committee.

Long Range Traffic and Pedestrian Safety Planning Committee Report-Mr. Collander explained that the report addresses vehicular, pedestrian and bicycle safety issues in the Borough. Included in the report is a map indicating where the school crossing guards are located, traffic signals, crosswalks, what streets have sidewalks and sanctioned and unsanctioned paths to the schools. There is also a school guard report for school year 2011-2012. Mr. Collander stated there are approximately 19,000 cars traveling on Main Street each day and between 12,000 and 20,000 on Watchung Avenue. There is traffic each day going to the six schools in Chatham and Chatham Township and there are soon to be seven pre-schools in town. The goal of the Committee is to make travel safe in the Borough. The Police Department has over the past 10 years participated in many school safety and pedestrian safety programs. The Council needs to update the sidewalk ordinance and decide whether to enforce the current requirement that property owners must pay for sidewalk replacement when the damage is not due to a Borough tree.

Council President Resto had concerns about some of the intersections in the Borough.

Ruth Dekker a member of the Safe Routes to Schools Committee thanked the Borough especially Vince DeNave and Officer Sweetin for their cooperation and their work with the Committee.

Kathy Abbott a member of the Safe Routes to Schools Committee applauds the cooperation between the Township and the Borough.

Barb Montague of 45 Dellwood Avenue stated the seniors do not use the library very much because of the parking situation.

Bill Heap of 108 Hillside Avenue reported the Jaycee's tree sale was very successful. He presented the Mayor with a check for \$2,500.00 for the Shade Tree Commission.

Mayor Harris closed the meeting to the public.

Mr. Falzarano met with Jen Kaplan to review the mural contract proposals. The contract was signed and sent back to NJ Transit. The Borough calendars were delivered on December 28th. The first part of the Chatham shade tree inventory

was done. The intern should return in May to complete the project. The Riker radio tower is in operation, which should improve radio reception for our police and fire departments. Mr. Falzarano, Mr. DeNave and Mr. Venezia met with Stan Prater from JCP&L about JCP&L's lack of a tree removal policy. Mr. Falzarano is working on the budget, annual report and goals and objectives.

WHEREAS, the Borough of Chatham and New Cingular Wireless PCS, LLC ("New Cingular") entered into a Lease Agreement dated April 22, 2002, whereby the Borough leased certain premises being a portion of the property located at 54 Fairmount Avenue, Chatham, New Jersey to New Cingular Wireless PCS, LLC a Delaware Limited Liability Company (the "Lease Agreement"); and

WHEREAS, the Borough and New Cingular Wireless PCS, LLC wish to amend the Lease Agreement to allow for the installation of additional antennas, associated cables and other communications instruments; and

WHEREAS, the amendment to the Lease Agreement shall be memorialized in substantially the same form of agreement attached hereto and made a part hereof.

BE IT RESOLVED, by the Mayor and Council of the Borough of Chatham as follows:

- 1. The Mayor and Borough Clerk of the Borough of Chatham be and hereby are authorized to execute an amendment to the Lease Agreement with New Cingular Wireless PCS, LLC in substantially the same form of agreement attached hereto and made a part hereof.
- 2. All Borough officials are hereby authorized and directed to take all action necessary and appropriate to effectuate the terms of this Resolution.
