REGULAR MEETING OF THE MAYOR AND BOROUGH COUNCIL

March 28, 2016 MINUTES

Mayor Bruce A. Harris called the Regular Council Meeting of the Borough of Chatham to order on Monday, March 28, 2016 at 7:30 p.m. in the Council Chambers in Borough Hall, 54 Fairmount Avenue, Chatham, New Jersey.

SALUTE TO FLAG

The Mayor and Borough Council led the assembled in the Pledge of Allegiance.

MOMENT OF SILENCE

Mayor Harris asked for a moment of silence for those who have given their lives for our country.

STATEMENT OF ADEQUATE NOTICE

Mayor Bruce A. Harris proceeded with reading the following proclamation:

PROCLAMATION

NATIONAL AUTISM AWARENESS, ACCEPTANCE AND INCLUSION MONTH APRIL 2016

WHEREAS, autism is a pervasive developmental disorder affecting the social, communication and behavioral skills of those affected by it; and

WHEREAS, as more health professionals become proficient in diagnosing autism, more children are being diagnosed on the autism spectrum, resulting in rates as high as 1 in 68 children nationally and 1 in 45 in New Jersey; and

WHEREAS, while there is no cure for autism, it is well-documented that if individuals with autism receive early and intensive treatment throughout their lives, they lead significantly improved lives; and

WHEREAS, individuals with autism often require a lifetime of specialized and community support services to ensure their health and safety and to support families' resilience as they manage the psychological and financial burdens autism can present; and

WHEREAS, Autism New Jersey is spearheading an awareness effort in order to educate parents, professionals and the general public about autism and its effects.

BE IT RESOLVED that I, Bruce A. Harris, Mayor of the Borough of Chatham, do hereby proclaim April 2016 as NATIONAL AUTISM AWARENESS MONTH in the Borough of Chatham, and urge all employees and residents to participate in our municipality's National Autism Awareness Month activities, in order to become better educated about autism and create a better community for individuals with autism.

Council Member Fife made a motion to approve the proclamation. Council Member Resto seconded the motion. A vote was taken and the proclamation was approved unanimously.

Mayor Harris asked Council Member Peter Hoffman, liaison to the Board of Health, to proceed with reading the following proclamation:

PROCLAMATION

NATIONAL PUBLIC HEALTH WEEK APRIL 4-10, 2016

WHEREAS, since 1995, the American Public Health Association ("APHA") through its sponsorship of National Public Health Week has been educating the public, policymakers, and public health professionals on issues important to improving the public's health; and

WHEREAS, during the first full week of April each year, APHA brings together communities across the United States to observe National Public Health Week as a time to recognize the contributions of public health and to highlight issues that are important to improving the health of our nation; and

WHEREAS, some of the greatest achievements of public health include immunizing residents against diseases, identifying and controlling infectious diseases, preparing residents for public health emergencies, improving health for women and children, providing safer and healthier foods, implementing occupational health safety measures, and promoting healthy behaviors, including increased physical activity, good nutrition, and tobacco prevention and cessation; and

WHEREAS, public health is the foundation for a brighter tomorrow. When we invest in the safety and well-being of all Americans, we enrich our communities, bolster our economy, and strengthen our Nation.

BE IT RESOLVED, that I, Bruce A. Harris, Mayor of the Borough of Chatham, proclaim the week of April 4th through April 10th, 2016, as NATIONAL PUBLIC HEALTH WEEK in Chatham Borough, and together with the Borough Council and the Chatham Borough Board of Health, encourage all residents to observe National Public Health Week and to make healthy lifestyle choices to live healthier and longer lives.

Council Member Hoffman made a motion to approve the proclamation. Council Member Resto seconded the motion. A vote was taken and the proclamation was approved unanimously.

Council Member Hoffman presented the proclamation to Lisa DeRosa, President of the Chatham Borough Board of Health, and Lisbeth Bringgaard, Madison Health Department.

Lisa DeRosa thanked Mayor Harris and the Borough Council for recognizing National Public Health Week on April 4-10, 2016 by issuing this proclamation. Ms. DeRosa briefly spoke about the important work performed by public health departments throughout the country and the role of local Boards of Health. She thanked the team at the Madison Department of Health, as well as the members of the Chatham Board of Health, for attending to all matters concerning public health in our community. She also thanked Mayor Harris, the Borough Council and Borough employees for their support of the Chatham Board of Health.

Mayor Harris proceeded with Resolution #16-146.

Council Member Fife made a motion to approve Resolution #16-146. Council Member Resto seconded the motion. A vote was taken and Resolution #16-146 was approved unanimously.

DISCUSSION ITEMS

Eagle Scout Project – Matt Piechnik, an Eagle Scout candidate from Troop 8, presented his Eagle Scout service project to install drainage and erosion controls along the Jackson Avenue trail from Jackson Avenue to Kelley's Pond to reduce flooding and erosion along the trail. Mr. Piechnik advised that materials would be a minimal expense and that the Department of Public Works would help by installing blue stone chips in the drainage channels.

The Mayor and Council thanked Mr. Piechnik for his presentation and agreed that his Eagle Scout service project would be beneficial to the community. An authorizing resolution is to be placed on the April 11th agenda for Council approval.

Mr. John Tancredi, a member of the Environmental Commission, advised that Mr. Piechnik had presented his Eagle Scout service project to the Environmental Commission and that the Environmental Commission has given its full support and endorsement for the project.

JCP&L Update – Rob Walton, representative from JCP&L, reported that crews were on the scene in the Borough to restore power caused by a fallen tree on Lafayette Avenue. He then informed Borough officials that JCP&L will begin tree trimming operations in the coming weeks at the Green Village substation, which may impact 3 to 4 homes in the Borough. Mr. Walton also advised that the Board of Public Utilities (BPU) recently adopted a new tree-trimming standard along power line rights-of-way. A new "ground to sky" tree-trimming standard would go into effect for power lines to/from a power substation to the first device or breaker along the line. For those lines, tree trimming crews would be

required to clear 15 feet around power lines, including 15 feet above power lines. Prior to commencing tree-trimming operations, Mr. Walton advised that JCP&L would notify mayors and other town officials two months in advance of scheduled tree-trimming. Lastly, Mr. Walton reported that JCP&L has instituted a "speaker's bureau" that is available to groups and allows JCP&L representatives to educate the public about JCP&L operations.

Mayor Harris inquired whether JCP&L replaces trees that would need to be removed as a result of the new aggressive tree-trimming standard. Mr. Walton responded that JCP&L would not be replacing, nor replanting, trees impacted by tree-trimming operations.

MEETING OPEN TO THE PUBLIC

NOTICE OF PUBLIC COMMENT TIME LIMIT

Hearing of citizens during the Public Comment section of the Agenda is an opportunity for any member of the public to be heard about issues, which are/are not topics scheduled for Public Hearing tonight. To help facilitate an orderly meeting, and to permit all to be heard, speakers are asked to limit their comments to a reasonable length of time.

Mayor Harris opened the meeting to the public.

George Stafford, Uphold the Highlands Director of the New Jersey Highlands Coalition, commented that the New Jersey Highlands Coalition (the "Coalition") consists of approximately 80 environmental groups and 600 individual members. He reported that the Coalition is opposing the Pilgrim Pipeline project and urged Borough officials to join the other towns that have adopted resolutions opposing the pipeline.

Mayor Harris informed Mr. Strafford that the Borough had already adopted such a resolution and created a Pilgrim Pipeline Advisory Committee to advise and update the Council on any news concerning the Pilgrim Pipeline project. He further mentioned that a Municipal Pipeline Group, consisting of 18 New Jersey municipalities, has been formed and that the group is retaining legal counsel in efforts to protect the interests of their respective communities. Mayor Harris welcomed any additional information that the New Jersey Highlands Coalition could share.

Seeing no one else wishing to comment, Mayor Harris closed the meeting to the public and proceeded with the Council Committee Reports.

Council President Lonergan arrived at 8:05 p.m.

REPORTS

COUNCIL COMMITTEE REPORTS

Budget and Finance – Council President Lonergan had nothing new to report.

Long Range Traffic & Pedestrian Safety Planning - Council Member Collander was absent.

Public Safety & Emergency Services - Council Member Collander was absent.

Personnel - Council Member Resto reported that the committee is scheduled to meet on Friday, April 8th and would be reviewing interview questions for the new police lieutenant position. He further reported that the Department of Public Works collective bargaining contract has been finalized.

Public Works Planning/Community Services - Council Member Fife reported that the Department of Public Works will perform drainage projects that would otherwise have cost the Borough over \$100,000.00.

She stated that significant cost savings were made possible by the Borough contracting out grass cutting services, which freed up public works crews to perform drainage projects. She also reported that a Public Works Planning meeting would be scheduled next month.

Council Member Hoffman, a member of the committee, inquired whether contracting out fall leaf collection services might also provide an opportunity to free up public works crews to do other work. The committee will further examine whether additional cost savings could be achieved by contracting out leaf collection services.

Shared Services & 3rd Party Agreements - Council Member Helfrich was absent.

MAYOR'S REPORT

Mayor Bruce Harris reported that he inquired of other towns what they are doing to manage the emerald ash borer ("EAB"). He reported that only Summit has initiated a program and that Chatham Borough is well positioned with its public notification, and education efforts, and treatment plan for Borough trees for the emerald ash borer.

Patrick Carroll, Shade Tree Commission Chairman, advised that tree surveys were conducted on trees located on public right-of-way. He reported that postcards would be sent to all borough households containing information about the EAB and that letters would be mailed to residents whose properties are adjacent to borough trees scheduled for EAB treatment.

Mayor Harris reported that New Jersey Transit continues its negotiations with bidders interested in opening a restaurant at the train station. He further reported that early registration for pool memberships would begin on April 1st and that discounted pool registration rates would be in effect April 1st through April 15th. Lastly, Mayor Harris reported that Catherine Marino, Chair of the Municipal Alliance of the Chathams, will be resigning from the organization effective June 30th and encouraged volunteers to consider joining the group.

ADMINISTRATOR'S REPORT

Mr. Falzarano reported that the Borough's 2015 Annual Report has been circulated to the Mayor and Council. He also reported that the Borough's Tax Maps have been approved and sent out for printing. The tax maps will also be available online with GIS mapping detail.

Mr. Falzarano thanked Council Member Fife and other elected officials who helped draft the Monuments and Memorials Policy and Procedures and mentioned that an approving Resolution has been placed on tonight's consent agenda for Council action.
