Council Member Helfrich made a motion to approve Resolution #16-229. Council Member Resto seconded the motion. A vote was taken and Resolution #16-229 was approved unanimously.

# **DISCUSSION ITEM**

**JCP&L Update** – Mr. Rob Walton, Jersey Central Power & Light Company (JCP&L) Area Manager for the Summit District, reported that JCP&L has submitted an application to the Board of Public Utilities seeking a 5.5% rate increase. If approved, he reported that the rate increase would go into effect in January 2017 and would generate approximately \$147 million in revenue. The proposed rate increase would cost JCP&L's average customer about \$6 per month. Mr. Walton further reported that the added revenue would be used for upgrading and expanding its infrastructure to meet customer demand throughout the state. He reported that JCP&L's last utility rate increase was in 2003.

Council Member Collander, liaison to the Shade Tree Commission, inquired about JCP&L's new "ground-to-sky" tree-trimming rules and questioned how JCP&L oversees its contractors in the performance of tree-trimming operations. Mr. Walton responded that the utility has a regulatory obligation to trim "ground-to-sky" along power lines running from a sub-station to the first protected device on a circuit. He stated that a JCP&L forester, who is a certified arborist, supervises all work being performed by tree-trimming contractors and has the authority to exercise some discretion as to the manner and extent a tree is trimmed. He also mentioned that JCP&L provides a two-month notification to a municipality in advance of scheduled tree-trimming work and a second two-week notification is then given before the commencement of tree-trimming operations. This notification allows municipal officials to contact JCP&L to address any concerns before the work is performed.

Council President Lonergan noted that some improvements have been made in electrical service delivery over the past few years and inquired whether JCP&L has plans to improve all of its lines and circuits in Chatham Borough. Mr. Walton responded that much of the transmission service work had been done in the Borough and circuit maps have been updated in GIS to help work crews identify where failures occur.

Council Member Resto inquired if JCP&L has a 5-year or 10-year capital plan that addresses overall infrastructure improvement projects. Mr. Walton answered that JCP&L has both a long-term and short-term capital project improvement plan for scheduling infrastructure maintenance and improvements.

Mayor Harris and the Borough Council thanked Mr. Walton for his informative presentation and confirmed that he or Council Member Collander will help to coordinate his attendance at an upcoming Shade Tree Commission meeting.

Seeing no one else wishing to comment, Mayor Harris closed the meeting to the public and proceeded with Council Committee, Mayor's and Administrator's Reports.

# **COUNCIL COMMITTEE REPORTS**

**Budget and Finance** – Council President Lonergan reported that the Borough received an interest rate of .72% on the \$5.2 Million BAN sale.

**Long Range Traffic & Pedestrian Safety Planning -** Council Member Collander reported that the Committee is working on a draft ordinance to regulate parking on Dellwood Avenue, which will be presented for first reading at the next meeting. The committee is also looking at overnight on-street parking.

Public Safety & Emergency Services - Council Member Collander had nothing new to report.

**Personnel** - Council Member Resto reported that the Committee met on June 17<sup>th</sup> and discussed revisions to the Personnel Policies and Procedures Manual. He further reported that interviews would be scheduled later in July for the Police Lieutenant position.

**Public Works Planning/Community Services -** Council Member Fife reported that the Committee would be meeting with the Director of the Department of Public Works, Tony Torello, and the Director of Community Services, Janice Piccolo, to discuss the planning and coordination of projects and resources between the two departments.

Shared Services & 3<sup>rd</sup> Party Agreements - Council Member Helfrich had nothing new to report.

# **MAYOR'S REPORT**

Mayor Harris reported that the State of New Jersey has issued a drought warning and reminded residents that restrictions regarding lawn watering are in place in the Borough. Mayor Harris further reported that he has been working with Steve Williams in efforts to contact Google so that street addresses in Chatham Borough versus Chatham Township are correctly distinguished on Google Maps. Lastly, Mayor Harris reminded everyone of the upcoming Fourth of July celebration activities in the Borough and invited everyone to attend.

# ADMINISTRATOR'S REPORT

Mr. Falzarano reported that the annual Fourth of July Firehouse inspection is scheduled for Monday, July 4<sup>th</sup>. Fire Chief Allan has requested that the Mayor and Council attend at 9:00 a.m. Mr. Falzarano further reported that the Director of the New Jersey Department of Transportation (DOT) has confirmed that it would be addressing the timing of the traffic lights on Route 124 (Main Street). Lastly, Mr. Falzarano reported that Morris County has launched a website to inform and assist municipal officials and property owners in their review of the new flood hazard maps provided by the Federal Emergency Management Agency (FEMA). The information will be posted on the Borough webpage.
