RESOLUTION CONGRATULATING SAGE ELDERCARE AS IT CELEBRATES ITS 50^{TH} ANNIVERSARY IN PROVIDING MEALS ON WHEELS SERVICE TO OUR COMMUNITY

WHEREAS, in October 1966, SAGE Eldercare began its Meals on Wheels program with funding received from the Summit Junior League and volunteers from several local organizations who were recruited to deliver the meals; and

WHEREAS, SAGE Eldercare is the oldest continuously run Meals on Wheels program in New Jersey and is one of more than 5,000 community-based senior nutrition programs across the country that are dedicated to addressing senior hunger and isolation by delivering meals to those who are homebound and unable to prepare food for themselves; and

WHEREAS, SAGE Eldercare's Meals on Wheels program currently serves about 44,000 meals to almost 250 clients annually in the communities of Berkeley Heights, Chatham, Madison, Millburn, Mountainside, New Providence, Short Hills, South Orange, Springfield, and Summit; and

WHEREAS, this year marks the 50th anniversary of SAGE Eldercare's Meals on Wheels program, which continues to deliver nutritious meals, friendly visits and safety checks to our seniors and help enable them to live healthier and more independent lives in their homes.

Council Member Resto made a motion to approve Resolution #16-313. Council Member Collander seconded the motion. A vote was taken and Resolution #16-313 was approved unanimously.

DISCUSSION ITEMS

Library Renovations – Mr. Andrew Hollander, Trustee for the Library of the Chathams, and Ms. Karen Brodsky, Director for the Library of the Chathams, presented a library renovation plan that would "Renovate, Modernize, and Reorganize" the Library. Mr. Hollander reported that the renovation plan includes infrastructure improvements, including HVAC, plumbing, electrical and security upgrades, as well as the reorganization and modernization of space within the library to meet the changing needs of its patrons. The library renovations would cost \$4.5 million, including \$1.7 million in infrastructure improvements, which have been deemed as necessities.

The proposed reorganization of the library's interior space would include amenities such as a new teen room, a STEM room for robotics, a reconfigured children's activity room, a more accessible and improved local history room, and a business center. The teen room and business center can also be used

as meeting rooms when availability allows. Mr. Hollander noted that improvements to the interior layout would make efficient use of existing space without the need to construct an addition to the library.

Mr. Hollander further reported that the library would contribute approximately \$1.2 million raised through donations, which includes a \$150,000.00 gift made by the Women's Club of Chatham and \$250,000.00 donated by the Edwin Kruse Estate. If approved, both Chatham Borough and Chatham Township would share the remaining \$3.3 million renovation costs.

Ms. Brodsky reported that construction is estimated to take fourteen to eighteen months and the footprint of the Library would not be altered. She noted that previous renovations were completed in a piecemeal fashion. She assured that this renovation plan provides a cohesive and comprehensive approach utilizing spaces efficiently.

Council President Lonergan and the Borough Council thanked Mr. Hollander and Ms. Brodsky for their informative presentation. Council President Lonergan mentioned that Borough and Township officials are scheduled to meet on Tuesday, November 15th to discuss the library's renovation plan and financing.

2016 Leaf Collection – Mr. Tony Torello, Public Works Director, provided an update on the 2016 Leaf Collection Program. He reported that Public Works crews have been busy throughout the Borough collecting leaves and are now on their fourth pass vacuuming leaves. Residents were reminded that the last leaf collection run would commence on Monday, November 28th and that leaves should not be placed at the curb after Sunday, November 27th. Mr. Torello reported that two curbside leaf bag collection days have been scheduled this year. Residents may bag leaves in paper bags for collection by Public Works crews on Tuesday, December 6th and Tuesday, December 13th.

Mr. Torello reported that the mulch site would be open Monday through Friday from 8:00 a.m. to 4:00 p.m. through December 9th, and would be closed on Thanksgiving day and the day after. The mulch site will close on Saturday, December 10th for the season. Mr. Torello informed everyone that the updated schedule has been posted on the Borough website.

2017 Fee Schedule: Recreation, Water, Solid Waste, Sewer and Others – Council President Lonergan reported that the Finance Committee has been reviewing fees for calendar year 2017. He stated that the Finance Committee recommends that the solid waste fee be increased from \$192.00 to \$207.00 and the sewer and water utility fees be increased 2%, respectively, to keep up with cost of living and operating costs.

MEETING OPEN TO THE PUBLIC

NOTICE OF PUBLIC COMMENT TIME LIMIT

Hearing of citizens during the Public Comment section of the Agenda is an opportunity for any member of the public to be heard about issues, which are/are not topics scheduled for Public Hearing tonight. To help facilitate an orderly meeting, and to permit all to be heard, speakers are asked to limit their comments to a reasonable length of time.

Council President Lonergan opened the meeting to the public.

Ann Frommer, 24 Coleman Avenue East, supported the library's renovation plan and asked that library trustees also consider making restrooms and all doors handicap accessible.

Terry Kandalaft, 169 Terrace Drive, President of the Women's Club of Chatham, supported the library's renovation plan and confirmed that the Woman's Club of Chatham has donated \$150,000.00, which is earmarked specifically for the renovation of the teen room. Mrs. Kandalaft also commented that the lower level of the library is currently dimly lit and lacks security, which she said is addressed by the renovation plan.

John Eyre, 27 Fairview Avenue, supported the library's renovation plan and encouraged the Mayor and Council to support the capital improvements.

Gerry Geisler, 134 Hillside Avenue, supported the library's renovation plan and asked the Mayor and Council to support the capital improvements.

Julie Moran, 23 Orchard Road, introduced herself as a teacher at St. Patrick School, and expressed her enthusiasm and support of a STEM room at the library. She commented that children are very interested in STEM and commented that providing dedicated space in the library would be very beneficial.

Susan Allen, 167 Fairmount Avenue and Library Trustee, supported the library's renovation plan and further commented that she has learned much about the library and the Chatham community through her use of the local history room and its archives.

Seeing no one else wishing to comment, Council President Lonergan closed the meeting to the public.

Farmers' Market Advisory Committee - Council Member Fife invited residents to attend the Farmers' Market 10th year anniversary celebration scheduled this Saturday, November 19th, which will include a cake and recognition of the 97 volunteers who have helped the Farmers' Market over the past ten years.
