# PARENTS WHO HOST, LOSE THE MOST DON'T BE A PARTY TO TEENAGE DRINKING CAMPAIGN

**WHEREAS**, alcohol use by young people is dangerous, not only because of the risks associated with acute impairment, but also because of the threat to their long-term development and well-being; and

**WHEREAS**, adults who provide alcohol to those below the legal drinking age of 21 are placing those youth at risk for health, safety and legal problems; and

**WHEREAS**, it is illegal to give or allow your teen's friends to drink alcohol in your home, even with their parents' permission, and anyone found guilty of providing alcohol to youth can face up to a \$1,000 fine and six months in jail in addition to any civil action that can be brought as a result of damages or injury related to the offense; and

**WHEREAS**, adults have the authority and responsibility to provide our youth with alternative opportunities by creating alcohol free activities; and

**WHEREAS**, the Drug-Free Action Alliance, through the "Parents Who Host, Lose The Most: Don't be a Party to Teenage Drinking" campaign provides the educational materials to raise community awareness regarding this illegal and unhealthy practice;

**BE IT RESOLVED**, by the Mayor and Council of the Borough of Chatham that they hereby proclaim the month of June 2017 to be the Parents Who Host, Lose The Most: Don't be a Party to Teenage Drinking Month in the Borough of Chatham; and

**BE IT FURTHER RESOLVED,** that Borough officials not only discourage the use of alcohol by those below the legal age of consumption, but also urge all Borough citizens to refuse to provide alcoholic beverages to underage youth and to continue to take the necessary steps to discourage this illegal and unhealthy activity.

Council Member Helfrich made a motion to approve Resolution #17-172. Council Member Collander seconded the motion. A vote was taken and Resolution #17-172 was unanimously approved.

Mayor Harris presented Kelly Loofbourrow, Chair, and Vince Fiorito, Co-Chair, of the Municipal Alliance Committee of the Chathams with the Resolution.

Ms. Loofbourrow and Mr. Fiorito thanked Mayor Harris and the Council for their continued support of the Municipal Alliance Committee of the Chathams over the past 9 years. Ms. Loofbourrow mentioned that the Municipal Alliance of the Chathams is working with the school district, the Madison Chatham Coalition, local law enforcement, and Chatham Township and Chatham Borough officials in promoting preventative drug and alcohol programs. She welcomed anyone who is interested to join them.

Mayor Harris asked Council Member Collander to proceed with Resolution #17-173.

# DESIGNATING THE WEEK OF MAY 21-27, 2017 AS NATIONAL EMERGENCY MEDICAL SERVICES WEEK

**WHEREAS**, Emergency Medical Services are a vital public service, providing lifesaving care to those in need 24 hours a day, seven days a week; and

**WHEREAS,** the Emergency Medical Services system consists of emergency physicians, emergency nurses, emergency medical technicians, paramedics, firefighters, educators, administrators and others; and

**WHEREAS**, Emergency Medical Services are now firmly established as a key component of the medical care continuum and EMS practitioners serve a vital role in saving lives from sudden cardiac arrest and trauma; in getting people to the hospitals best equipped to treat heart attacks and strokes; and in showing caring and compassion to their patients in their most difficult moments; and

**WHEREAS**, access to quality emergency care dramatically improves the survival and recovery rate of those who experience sudden illness or injury; and

**WHEREAS**, the all-volunteer Chatham Emergency Squad has primary responsibility for responding to medical emergencies in the Chathams and provides CPR training and First Aid training to residents of the Chathams to improve preparedness for medical emergencies; and

**WHEREAS**, our community is fortunate to be served by such dedicated volunteers who give their time in service of the Chatham Emergency Squad and engage in hundreds of hours of specialized training to enhance lifesaving knowledge and skills; and

**WHEREAS**, National Emergency Medical Services Week brings together local communities and medical personnel to publicize safety and honor the dedication of those who provide the day-to-day lifesaving services of medicine's "front line."

**BE IT RESOLVED**, by the Mayor and Council of the Borough of Chatham that they do hereby proclaim the week of May 21-27, 2017 as Emergency Medical Services Week in the Borough of Chatham and give a heartfelt thanks to the dedicated volunteers of the Chatham Emergency Squad; and

**BE IT FURTHER RESOLVED** that residents are encouraged to join the Chatham Emergency Squad and become part of an organization, which has proudly served the Chathams since 1936.

Council Member Collander made a motion to approve Resolution #17-173. Council Member Helfrich seconded the motion. A vote was taken and Resolution #17-173 was unanimously approved.

Council Member Collander thanked the Chatham Emergency Squad for the vitally important services it provides to the community and applauded the volunteers for their dedication of service.

Mr. Steve Davenport, Operations Lieutenant with the Chatham Emergency Squad, accepted the Resolution from Mayor Harris and thanked him and the Borough Council for recognizing the Chatham Emergency Squad. He also recognized and thanked the Police, Fire and Public Works Departments, as well as the Administration for their support and partnerships.

Council Member Resto made a motion to approve Resolution #17-174. Council Member Lonergan seconded the motion. A vote was taken and Resolution #17-174 was approved unanimously.

### **DISCUSSION ITEMS**

**2017-2018 School District of the Chathams Budget** – Dr. Michael LaSusa, Superintendent of the School District of the Chathams, and Ms. Jill Critchley Weber, President of the Board of Education, presented an overview of the proposed 2017/2018 school district budget.

Dr. LaSusa opened the presentation by reporting on the three major factors that affected the 2017/2018 school budget: State aid, increases in student enrollment, and rising health insurance costs. He reported that the funding formula used by the state to allocate state aid, disproportionately and negatively affects the school district. He reported that while student enrollment continues to increase, state aid funding has continued to decrease.

The School District of the Chathams per pupil budgetary cost is \$14,858, which was reported to be lower than similar school districts such as Princeton, Millburn, Summit and Madison. Dr. LaSusa further reported that 4,206 students are currently enrolled district-wide. Approximately 600 students are enrolled in the special needs program (15% of total student enrollment). Student classroom size averages about 25 students.

Ms. Critchley Weber reported that health insurance costs increased 14.5% for the school district. She reported that the school district continues to address the rising cost of healthcare plan benefits by examining healthcare plan options with its broker and now offers two health plans. Incentives are provided to those employees who select the high deductible POS healthcare plan. She mentioned that collective bargaining negotiations have been successful in limiting "richer" plans previously given and confirmed that all employees contribute to their health insurance premiums in accordance with Chapter 78.

Ms. Critchley Weber then reported that the school district's 2017/2018 Local Tax Levy is \$61,921,960, representing a 2.95% increase. The estimated school tax impact for a home assessed at \$670,694 in the Borough would increase \$280.75.

The Council inquired how the Board of Education would be paying for the recently approved \$2.6 million central office building. Ms. Critchley Weber responded that the funding for the construction of the new central office building will come from its capital reserves plus and additional \$500,000 will come from from excess surplus. Dr. LaSusa further explained that the Board of Education offices have outgrown its facilities, and the red barn building has been deemed inhabitable. The new central office building will house all administrative staff and files at one secure location.

Mayor Harris and the Borough Council thanked Dr. LaSusa and Ms. Critchley Weber for their informative presentation.

In the interest of the late hour, Mayor Harris changed the order of the agenda and proceeded with opening the meeting to the public for comments.

### MEETING OPEN TO THE PUBLIC

### NOTICE OF PUBLIC COMMENT TIME LIMIT

Hearing of citizens during the Public Comment section of the Agenda is an opportunity for any member of the public to be heard about issues, which are/are not topics scheduled for Public Hearing tonight. To help facilitate an orderly meeting, and to permit all to be heard, speakers are asked to limit their comments to a reasonable length of time.

Mayor Harris opened the meeting to the public.

Rosanne Maraziti, 50 Inwood Road, expressed her support of the artwork on the traffic signal box on the corner of Fairmount Avenue and Watchung Avenue. She proposed that the Public Arts Council work with the homeowner to determine artwork for the traffic signal box that would be mutually-agreeable and requested that the Mayor and Council postpone Resolution #17-178 until a compromise can be achieved.

April Kabbash, 60 Watchung Avenue, praised the "Green Takes Back Grey" initiative and expressed her support for the artwork that was begun on the traffic signal box at the corner of Fairmount Avenue and Watchung Avenue. She stated that children walking to and from school have learned more about the artistic process by seeing the artist's day-by-day progress. She commented that her young son, Caston, added that he enjoys the traffic signal box because it is nice and shows the artist's feelings about the spring season.

Ethan Wagner, grandson of artist, Jennifer Duteil, asked why the homeowner wants to paint the traffic signal control box gray again.

Jennifer Duteil, introduced herself as the crossing guard at corner of Watchung Avenue and Fairmount Avenue and the artist who has been designated by the Public Arts Council to paint the traffic signal control box at that intersection. She mentioned that the Public Arts Council obtained all approvals from the county, the Chatham Jaycees donated money for the art supplies, and artists and volunteers donated much time to the project. She also commented about her experience painting this traffic control signal box and the abrupt encounter with the homeowner while painting.

Amy Wagner, 129 Fairmount Avenue, commented that she believed adequate notice was provided to residents about the "Green Takes Back Grey" project. She stated that the Public Arts Council presented the proposed project to the Mayor and Council in November and a Resolution was subsequently passed in December approving the project. She mentioned that the agendas for both meetings were available on the Borough website. Lastly, she questioned whether the Public Arts Council would need to obtain permission from the county to repaint the traffic signal control box gray.

Michael Dean, 181 N. Passaic Avenue, thanked Council Member Hoffman for asking relevant questions during the 2017-2018 School District of the Chathams budget discussion and commented that Borough officials must consider impacts to student enrollment with the proposed redevelopment project. He reserved further questions about the proposed redevelopment project until the Post Office Plaza Preliminary Investigation Study has been presented to the Mayor and Council.

Roger Eveleth, 133 Fairmount Avenue, expressed his support to promote beautification projects throughout the Borough and encouraged the Mayor and Council to continue to approve future public art projects.

George Sweetin, 19 Cornell Place, thanked Mr. Falzarano for his years of service to the Borough and commented about several safety concerns he witnessed during the May 6<sup>th</sup> Spring Clean event so that they do not occur next year. He further commented that young volunteers are over-mulching the tree and shrubbery beds, which can eventually smother and kill the trees and shrubs.

Seeing no one else wishing to comment, Mayor Harris closed the meeting to the public and proceeded with the Post Office Plaza Preliminary Investigation Study discussion item.

**Post Office Plaza Preliminary Investigation Study** – Mr. John Hague, Esq., special legal counsel for the proposed redevelopment project, provided a brief overview of the redevelopment process and legal authority for redevelopment in the state of New Jersey. He reported that earlier this year, the Mayor and Borough Council adopted a Resolution directing the Planning Board to undertake a preliminary investigation to determine if certain properties qualify as a non-condemnation Area in Need of Redevelopment pursuant to the criteria in New Jersey's Local Redevelopment and Housing Law ( the "Redevelopment Law").

Mr. Hague reported that the Planning Board retained the services of Mr. Phil Abrams, a planner with the firm Topology, a professional planning firm, to conduct the necessary investigations to determine whether the study area qualifies as an Area in Need of Redevelopment under the criteria set forth in the Redevelopment Law. Topology conducted such investigations and prepared a report of its findings entitled,

"Preliminary Investigation Post Office Plaza Chatham New Jersey" dated March 22, 2017 (the "Preliminary Investigation Report").

Mr. Hague continued that on April 5, 2017, Mr. Abramson presented the Preliminary Investigation Report to the Planning Board and a public hearing was conducted. The Planning Board subsequently adopted a Resolution recommending to the Mayor and Borough Council that the Post Office Plaza study area (the "Study Area") be designated as an Area in Need of Redevelopment.

Mr. Hague concluded by reporting that the current step in the redevelopment process is for the Mayor and Borough Council to accept, reject or modify the recommendations presented in the Preliminary Investigation Report. He turned the presentation over to Mr. Phil Abramson.

Mr. Abramson began his presentation by reporting that the redevelopment law allow municipalities to use planning and financial tools to remove deleterious conditions and make redevelopment possible. He mentioned that the Preliminary Investigation Report provides an analysis of the Study Area and recommended course of action.

The Study Area is adjacent to the Chatham train station and comprises 14 properties on 5.5 acres straddling Bowers Lane from Main Street to the Morris and Essex Railroad line. The Study Area includes a mix of single-use commercial and residential structures that lie in the B-4 (Community Business) District, AFD-4 (Affordable Housing) District, and B-3 (General Business) District. Properties in the Study Area include:

Mr. Abramson reported that the preliminary investigation was to determine whether the designation of these properties qualify as a non-condemnation Area in Need of Redevelopment in conformance with the statutory criteria in N.J.S.A. 40A:12A-5. He confirmed that each of the property owners within the Study Area had been contacted and each expressed their interest in the proposed redevelopment. He noted that Block 121, Lot 14, a South Passaic Avenue storefront, would not be included in the proposed Area in Need of Redevelopment.

Mr. Abramson then reported on the statutory criteria applicable to each of the parcels in the Study Area. He concluded his presentation by reporting that the next step is for the Mayor and Borough Council to accept, reject or modify the recommendations presented in the Preliminary Investigation Report and begin the planning process.

Mayor Harris thanked Mr. Hague and Mr. Abramson for their presentation and announced that the planning process phase for the proposed Post Office Plaza Redevelopment Project will begin with a community visioning session that is scheduled for June 15<sup>th</sup> at 7:00 p.m. at Borough Hall and encouraged public participation.

### **REPORTS**

### **BOARD & COMMISSION MEMBERS & LIAISON REPORTS**

Due to the late hour and additional business to conduct, the Borough Council agreed to forego its Liaison Reports.

Council Member Collander mentioned, however, that the Shade Tree Commission will now be holding monthly meetings instead of bi-monthly effective this month.

### MAYOR'S REPORT

Mayor Harris reported that the Milton Avenue School polling location has been moved to the Chatham Middle School. The Borough Clerk's office has mailed notifications to the affected registered voters.

# ADMINISTRATOR'S REPORT

Mr. Falzarano reported that flowers have been planted at Liberty Park and the paver pathway installed. He further reported that the Department of Public Works is constructing the new façade and roof on the pavilion located in Shepard Kollock Park and that the backstop and fencing at the ball fields have been installed.

# **CONSENT AGENDA**

The following items are considered routine by the Chatham Borough Council and will be enacted by one motion. There will be no separate discussion of these items unless a Council Member so requests, in which event the item will be removed from the Consent Agenda and considered in its normal sequence on the Agenda.

## **RESOLUTION #17-178**

# RESOLUTION DIRECTING THAT THE TRAFFIC CONTROL CABINET LOCATED AT THE INTERSECTION OF WATCHUNG AVENUE AND FAIRMOUNT AVENUE IN THE BOROUGH OF CHATHAM BE RESTORED TO ITS ORIGINAL CONDITION

**WHEREAS**, by Resolution #16-342 adopted on December 12, 2016, the Borough Council granted permission to the Public Arts Council (Advisory Committee) ("PAC") to paint three traffic control cabinets located at the intersections of Watchung Avenue and Hillside Avenue, Watchung Avenue and Fairmount Avenue, and Watchung Avenue and Washington Avenue with environmental themes for its "Green Takes Back Grey Project;" and

**WHEREAS,** upon further information and discussion by the Mayor and Council at its meeting held on April 24, 2017, it was concluded that the traffic control box located at the intersection of Watchung Avenue and Fairmount Avenue should be removed from the PAC "Green Takes Back Grey Project" and restored to its original condition.

**BE IT RESOLVED,** by the Mayor and Council of the Borough of Chatham that the traffic control box located at the intersection of Watchung Avenue and Fairmount Avenue be removed from the PAC "Green Takes Back Grey Project" and restored to its original condition by the Department of Public Works; and

**BE IT FURTHER RESOLVED,** that all Borough officials are hereby authorized and directed to take all action necessary and appropriate to effectuate the terms of this Resolution.

Mayor Harris asked if there was discussion on Resolution #17-178.

Council Member Resto and Council Member Collander both were supportive of the Public Arts Council's "Green Takes Back Grey" project and suggested that representatives of the Public Arts Council meet with the homeowners to come to a mutually-agreed upon compromise that would allow the traffic signal box to be painted with artwork.

Council Member Lonergan mentioned that "art is in the eye of the beholder." He expressed his support for the Public Arts Council and suggested that the coloring of the artwork proposed for the traffic signal box at the Fairmount and Watchung Avenues intersection be modified to blend in more with the surroundings.

Council Member Hoffman stated that it was his opinion that art belongs in public parks and in front of public buildings, and in public gathering spaces and that it is a very different standard of proof when artwork is presented in front of someone's home. He inquired if there was another location in town where that artwork could be recreated. He suggested that the traffic signal box be restored to its original finish until such time in the future that the homeowner and Pubic Arts Council come to an agreement on a different design

Mayor Harris mentioned that a vote to restore this traffic signal box to its original condition is not at all a denigration of the Public Arts Council, nor a commentary on how we feel about public art. Instead, he stated that it is more of a reflection of the balance of private interests and public interests. He highlighted the many public art initiatives undertaken by the Public Arts Council and thanked them for their incredible contributions to the Borough over the years.

Council Member Helfrich stated he was hesitant to take action and stated that he would have made a motion to table Resolution #17-178 but a motion has already been made.

Mayor Harris confirmed that Council Member Resto asked to remove Resolution #17-178 from the Consent Agenda and put it on the floor for discussion and action. He then moved the Resolution and the motion was seconded by Council Member Hoffman.

Council Member Helfrich questioned whether a Council Member who intends to vote "no" is allowed to make the motion.

Mayor Harris stated that if there is a concern whether or not it has been properly moved, then someone else can make a motion to move Resolution #17-178. Mr. Lott concurred and advised that it did not matter how the person making the motion intends to vote on the motion. He further confirmed that there wasn't any procedural irregularity.

Council Member Hoffman made a motion to approve Resolution #17-178. Council Member Lonergan seconded the motion.

Mayor Harris asked the Borough Clerk for a Roll Call Vote.
