# **RESOLUTION #17-185**

# RESOLUTION RECOGNIZING JEFFREY DAVIS FOR HIS GENEROSITY AND EXEMPLARY SERVICE TO CHATHAM BOROUGH

**WHEREAS,** Jeffrey Davis is the owner of Specialized Auto Craft, a family-operated business in Chatham Borough since 1973; and

WHEREAS, Jeff has demonstrated himself to be a thoughtful, caring citizen and businessman in the Borough, who at all times dedicates himself to preserving the Borough's small town character and spirit of volunteerism that has helped make Chatham Borough the town we love.

**WHEREAS,** Jeff is to be recognized and commended for his generosity and exemplary service that he has demonstrated to our community over the years.

**BE IT RESOLVED,** by the Mayor and Council of the Borough of Chatham that they do hereby extend their grateful appreciation to Jeffrey Davis for restoring the Reasoner Park clock and on behalf of our entire community and citizenry commend him for his loyal support, generosity, and exemplary service to our community over the years.

# RESOLUTION SUPPORTING MORRIS COUNTY'S MENTAL HEALTH "STIGMA-FREE" INITIATIVE BY DESIGNATING THE BOROUGH OF CHATHAM AS A "STIGMA-FREE" COMMUNITY

WHEREAS, the Morris County Department of Human Services recognizes that one in four Americans have experienced mental illness, including substance abuse, in any given year according to the National Institute of Mental Health (NIMH); and

**WHEREAS,** mental health problems are more common than cancer and heart disease combined; and,

WHEREAS, mental health issues affect both children and adults, including more than half of our Iraq and Afghanistan War veterans treated at Veteran's Administration hospitals, making mental illness a public health problem which is very real in our communities; and

**WHEREAS,** the stigma associated with mental health and substance abuse disorders is identified as the primary reason individuals fail to seek the help they need to recover from these disorders; and

WHEREAS, "Stigma-Free" communities aim to inspire and raise public interest and open dialogue about stigma, raise awareness of mental health and substance abuse disorders and create a culture wherein residents with mental health and/or substance abuse disorders feel supported by their community and neighbors and free to seek treatment without fear of stigma; and

WHEREAS, promoting awareness that there can be no "health" without mental health, will break down barriers and encourage residents of all ages to be mindful of their mental health and ask for help when needed, as well as educating us to be more able to discern the signs of situations where assistance is called for; and

**WHEREAS,** local resources are available to treat mental health and substance use disorders so no one needs to suffer alone or feel helpless.

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Council of the Borough of Chatham that the Borough of Chatham joins Morris County's "Stigma-Free" Community Initiative by declaring the Borough of Chatham as a "Stigma-Free" Community and encourages every resident to make themselves more aware of mental health issues as a means to combat the rising rates of depression, anxiety, suicide and all other mental health disorders.

Council Member Resto made a motion to approve Resolution #17-186. Council Member Collander seconded the motion. A vote was taken and Resolution #17-186 was approved unanimously.

Mayor Harris asked the Borough Clerk to forward a copy of the Resolution to the Morris County Chosen Board of Freeholders.

Council Member Resto made a motion to approve Resolution #17-187. Council Member Collander seconded the motion. A vote was taken and Resolution #17-187 was approved unanimously.

#### **DISCUSSION ITEMS**

**Build Out Analysis** – Dr. Susan Blickstein, the Borough's Planner, and Ms. Kendra Lelie, a planner with the firm Clarke Caton Hintz, presented the *Chatham Borough Sewer Demand Projection Technical Study*.

Dr. Blickstein reported that the technical study is designed to assist the Madison-Chatham Joint Meeting in projecting the build out of future development and estimation of sewerage treatment that may be needed over the next 10-15 years for both communities. She mentioned that the analysis presented in the report is only for sewer capacity decision-making purposes.

Sewer demand projections were based on regional population and housing projections, GIS data obtained from Morris County for the Borough, trends in recent development approvals, and historic construction permit data. Five potential growth areas were identified: Gateway Area, B-5 Zone along Main Street, Post Office Plaza, Train Station Area, and the Garden Apartments.

The results of the sewer demand projection indicate an estimated need of 217,725 gallons per day (GPD) of sewer capacity, or approximately a 14% increase. This sewer capacity percentage, which includes a contingency factor, is the capacity that would likely be needed to accommodate new residential and commercial development that may take place over the next 10-15 years.

Dr. Blickstein reported that the buildout analysis for Madison Borough would be presented to the Madison Borough governing body in the near future.

**Capital Projects Update** – Mr. Vince DeNave, Borough Engineer, provide an update on the following 2017 capital projects:

- 1. The Weston Road Improvement Project, along with several roadway resurfacing projects, are scheduled to begin at the end of the school year.
- 2. The award of a contract for the 2017 Curb and Sidewalk Program is listed on the agenda for Council approval. Curbs and sidewalks in Zone 5, as well as the installation of a new sidewalk for the east side of North Passaic Avenue to the bridge at the Florham Park municipal boundary are included in this year's program. There are no planned street tree removals for the scheduled curb and sidewalk locations.
- 3. Improvements to Kelley's Pond, including bank stabilization, tree trimming, and the rehabilitation of the footbridge have been completed. A new electrical system will be installed and the installation of bubblers in the pond to improve aquatic conditions will also be completed. Mr. DeNave reported that the Chatham Fire Department Association made a generous donation for the improvements to Kelley's Pond and the Department of Public Works has performed all of the work with exception of the installation of the new electrical system. Additionally, grant funding from Sustainable Jersey will be used to plant milkweed to attract monarch butterflies and other improvements.
- 4. Several improvements to Sheppard Kollock Park, including the installation of new backstops and fencing at the ball fields and repairs to the park pavilion have been completed. Phase I of the Historic Riverside Trail will begin soon and the Borough will be applying for new grant funding for Phase II. A resolution authorizing Mayor Harris to execute a letter of intent for submission of a Morris County Trail Construction Grant is on the agenda for Council approval.
- 5. Drainage projects along Clark Street and North Summit Avenue have been completed by the Department of Public Works. Mr. DeNave reported that the Borough is able to complete many drainage projects at substantial cost-savings by performing the work in-house.
- 6. Improvements to Liberty Park, including bank stabilization, fencing, and paver walkways and landscaping have been completed. Installation of park benches and a widening of the sidewalk near the crosswalk to accommodate students walking to and from school are scheduled.
- 7. Mr. DeNave reported capital improvements to Well #2 have been completed. Well #3 and the water tank are scheduled for repairs.

Mr. DeNave further reported that the summer intern program has begun. Intern projects include using GIS to update the Borough's tree inventory and to report and track road conditions for all Borough roadways.

The Council inquired about the status of new lighting at the Center Avenue East parking lot and the status of NJ Transit's repairs to the bridge abutments on Fairmount Avenue and Hillside Avenue. Mr. DeNave responded that new lighting for the Center Avenue East parking lot is currently being investigated. He had nothing new to report on the status of repairs to be made to the two bridge abutments by NJ Transit.

# MEETING OPEN TO THE PUBLIC

# NOTICE OF PUBLIC COMMENT TIME LIMIT

Hearing of citizens during the Public Comment section of the Agenda is an opportunity for any member of the public to be heard about issues, which are/are not topics scheduled for Public Hearing tonight. To help facilitate an orderly meeting, and to permit all to be heard, speakers are asked to limit their comments to a reasonable length of time.

Mayor Harris opened the meeting to the public.

Diane Conlan, 22 Garden Avenue, voiced her concern that many mature trees are being taken down on residential lots for new construction and urged Borough officials to help take action to prevent indiscriminate removal of trees.

Council Member Collander responded that the Shade Tree Commission is scheduled to make a presentation to the Mayor and Council on June 12<sup>th</sup> and invited Mrs. Conlan to attend that meeting.

Mayor Harris assured Mrs. Conlan and the public that the Planning Board actively reviews and questions all site plan applications.

Mr. DeNave further stated that a Continued Certificate of Occupancy is not issued until the site plan, including drainage and landscaping matters have been satisfied.

Fran Drew, 32 Inwood Road, reported on the number of trees that had been taken down in the Borough over the past 4 years based on her review of tree removal permits that had been issued. She presented photographs of take downs of significant sized trees and urged Borough officials to stop the needless removal of mature trees.

Jack Drew, 32 Inwood Road, commented that the Borough should regulate trees on private property since trees and a mature tree canopy significantly affects the character of a community. Mr. Drew also inquired about Resolution #17-188.

Mayor Harris responded that the adoption of Resolution #17-188 would designate certain properties in and around Post Office Plaza as a non-condemnation Area in Need of Redevelopment and further informed that the planning study report presented at the May 8<sup>th</sup> Mayor and Council meeting is available on the website.

Mayor Harris informed Mr. Drew and the public that a community-visioning forum is scheduled for June 15<sup>th</sup> at 7:00 p.m. at the Chatham Middle School and encouraged residents to attend.

Stewart Carr, resident of Chatham Township, questioned whether the School District of the Chathams presented a formal agenda to the Mayor and Council for the expansion of the Washington Avenue School parking lot and inquired if potential impacts to the school district's student enrollment were available regarding the build out of the proposed Post Office Plaza redevelopment.

Mayor Harris informed Mr. Carr that the school district presented a site plan application to the Planning Board and had many discussions with the Council's Long Range Traffic & Pedestrian Safety Planning Committee.

The Council further informed Mr. Carr that the limited on-street parking in the residential area, coupled with increased parking needs for train station commuters, were key factors in the Borough working with the school district to expand the Washington Avenue School parking lot.

Rozella Clyde, 33 Carmine Street, questioned if the Borough will publicize the new trails along the Passaic River for public enjoyment once completed.

Joe Marts, 14 W. Coleman Avenue and former Mayor, inquired if developers will be required to improve water and sewer infrastructure as part of a developer's agreement.

Mayor Harris responded that the Borough would have discussions with its special redevelopment council to address needed infrastructure improvements as part of the redevelopment project.

Seeing no one else wishing to comment, Mayor Harris closed the meeting to the public.

# **COUNCIL COMMITTEE REPORTS**

**Budget and Finance** – Council Member Lonergan reported the 2018 budget process is on track.

Council Member Lonergan announced that a Community Forum is scheduled for May 30<sup>th</sup> at 7:00 p.m. at the Chatham High School Auditorium to discuss the crisis of opioid and heroin addiction among teens and young adults. A panel of speakers will engage parents with information on current trends, signs and symptoms, and life-saving resources. Council Member Lonergan encouraged the public to attend.

**Long Range Traffic & Pedestrian Safety Planning -** Council Member Collander reported the next meeting is scheduled for Thursday, June 1<sup>st</sup> and had nothing new to report.

**Public Safety & Emergency Services -** Council Member Collander reported the next meeting is scheduled for Thursday, May 25<sup>th</sup> and had nothing new to report.

**Personnel** - Council Member Resto reported that personnel matters have been scheduled for closed session discussion.

Council Member Resto announced that the Chatham Memorial Day Commemoration would be held at the memorials in front of the Library of the Chathams on Monday, May 29th. The program will begin at 8:00am with many veterans having confirmed their attendance.

**Public Works Planning/Community Services -** Council President Fife reported that Fishawack is scheduled for June 10<sup>th</sup>. The Jaycee's Fishawack Race begins at 9:00 a.m. followed by a full day of events, activities, and a Movie under the Stars at 8:00 p.m. There will also be a rededication of a tree and plaque memorializing those in Chatham who gave their lives in service to their Country during World War I. The event will take place during Fishawack, at noon at Borough Hall, Saturday, June 10<sup>th</sup>.

**Shared Services & 3<sup>rd</sup> Party Agreements -** Council Member Helfrich had nothing new to report.

# **MAYOR'S REPORT**

Mayor Harris announced that a community-visioning forum to discuss the proposed Post Office Plaza redevelopment project is scheduled for June 15<sup>th</sup> at 7:00 p.m. at the Chatham Middle School. He encouraged residents to attend and to provide their input. Mayor Harris also reported that the Borough nominated "Monty" and Barbara Montague for the "Cissy Laureys" Award, an award established by Morris County Clerk, Ann Grossi, to recognize seniors for their outstanding community service. Each year, one deserving county citizen is recognized for his/her outstanding community service. "Monty" and Barbara Montague and were recognized by Morris County for their years of volunteer service.

# **RESOLUTION #17-188**

RESOLUTION OF THE BOROUGH OF CHATHAM, COUNTY OF MORRIS, NEW JERSEY, DESIGNATING AN AREA OF THE BOROUGH AS MORE PARTICULARLY DESCRIBED HEREIN AS "AN AREA IN NEED OF REDEVELOPMENT" PURSUANT TO THE LOCAL REDEVELOPMENT AND HOUSING LAW

**WHEREAS**, on March 13, 2017, the Mayor and Council adopted Resolution No. 17-093, requesting and authorizing the Planning Board to undertake a preliminary investigation to determine whether the properties identified as Block 121, Lots 10, 11, 12, 13, 14 and 17, and Block 122, Lots 1, 2, 13, 14, 15, 16, 17 and 18, as identified on the Official Tax Map of the Borough of Chatham (collectively, the "Study Area") to determine if such properties qualify as a "non-condemnation" area in need of redevelopment pursuant to the Local Redevelopment and Housing Law, *N.J.S.A.* 40A:12A-1, et seq. (the "Redevelopment Law"); and

**WHEREAS**, Resolution No. 17-093 provides in part that the powers of eminent domain may not be applied to the Study Area; and

**WHEREAS**, the Planning Board retained the services of Topology NJ, LLC, a professional planning firm ("Topology") to assist in conducting the necessary investigations and analysis to determine whether the Study Area does or does not qualify as an area in need of redevelopment under the criteria set forth in the Redevelopment Law; and

**WHEREAS**, Topology conducted such investigations and prepared a report of its investigations entitled "*Preliminary Investigation Post Office Plaza Chatham New Jersey*" dated March 22, 2017 (the "Redevelopment Investigation Report"); and

**WHEREAS**, the Redevelopment Investigation Report concludes that the Study Area, with the exception of Block 121, Lot 14, exhibit conditions which conform with various redevelopment criterion under Section 5 of the Redevelopment Law, *N.J.S.A.* 40A:12A-5, as more specifically set forth in the Redevelopment Investigation Report; and

**WHEREAS**, on April 5, 2017, the Planning Board conducted a duly-noticed public hearing, pursuant to *N.J.S.A.* 40A:12A-6, at which time it heard a presentation of the Redevelopment Investigation Report by Philip A. Abramson and Leigh Anne Hindenlang, the primary authors of the Redevelopment Investigation Report, as well as comments from members of the public in attendance; and

**WHEREAS**, Mr. Abramson and Ms. Hindenlang responded to questions from the Planning Board members and members of the public; and

WHEREAS, based upon the Redevelopment Investigation Report, Mr. Abramson's and Ms. Hindenlang's testimony concerning the Redevelopment Investigation Report, and the comments from the public, on April 19, 2017, the Planning Board adopted a Memorializing Resolution accepting the findings of the Redevelopment Investigation Report, concluding that Block 121, Lots 10, 11, 12, 13 and 17, and Block 122, Lots 1, 2, 13, 14, 15, 16, 17 and 18 (the "Revised Study Area") meet the criteria for designation as a non-condemnation area in need of redevelopment under the Redevelopment Law, and recommending that the Mayor and Council designate the Revised Study Area as a non-condemnation area in need of redevelopment, pursuant to the Redevelopment Law; and

**WHEREAS,** the Mayor and Council accept the conclusions of the Redevelopment Investigation Report and the Planning Board's recommendation and wish to designate the Revised Study Area as a noncondemnation area in need of redevelopment.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of Chatham that the Revised Study Area described herein be and hereby is designated as a Non-Condemnation Redevelopment Area, pursuant to *N.J.S.A.* 40A:12A-5 and *N.J.S.A.* 40A:12A-6.

Council President Fife made a motion to approve Resolution #17-188. Council Member Lonergan seconded the motion. A vote was taken and Resolution #17-188 was approved unanimously.
