Mayor Bruce A. Harris called the Regular Council Meeting of the Borough of Chatham to order on Monday, July 10, 2017 at 7:30 p.m. in the Council Chambers in Borough Hall, 54 Fairmount Avenue, Chatham, New Jersey.

Council Member Collander made a motion to approve Resolution #17-228. Council Member Resto seconded the motion. A vote was taken and Resolution #17-228 was unanimously approved.

DISCUSSION ITEMS

Morris County Budget – Freeholder Christine Myers and John Bonanni, Morris County Administrator, presented an overview of the 2017 Morris County Budget. Freeholder Myers reported that the 2017 county budget provides funding to maintain all current county services and, in some cases expands certain county services. She specifically pointed out that the budget includes the continuation of many cost-effective shared services in place with other counties and municipalities, and supports the County of Morris, the Morris County School of Technology, the Morris County Park System and all county infrastructure, including roads, bridges, railroads and buildings.

Freeholder Myers reported that the county's 2017 operating budget is \$332 million. She further reported that the county's ratable base increased \$1.5 billion, which helped to minimize the 2017 county tax rate of 1.79%, reflecting a \$14 per average household increase in the county tax. Freeholder Myers explained that the largest increase in costs in the 2017 operating budget were outside the county's control and included costs associated with health insurance benefit increases (a reported 12% increase over the prior year), anticipated salary adjustments (Mr. Bonanni reported that 90% of the county workforce are members of one of the county's 22 collective bargaining units), transition costs for the privatization of the county's Morris View Nursing facility, mandated criminal justice reform costs, pension increases, the county-wide EMS program (which currently serves 2/3 of the 39 municipalities in Morris County), state human services/mental health needs, and strategic planning initiatives.

Freeholder Myers and Mr. Bonanni reported that the county's 2017 capital budget authorizes \$27.1M in debt for county road projects, design and replacement of bridges, building improvements for criminal justice reform mandates, needed law and public safety equipment, educational facilities and information technology equipment.

Freeholder Myers advised that Morris County received Moody's AAA rating and is one of only six counties in the state to receive Moody's AAA rating. She concluded the budget presentation by reporting that the Morris County Board of Chosen Freeholders have adopted a report entitled, *Vision, Mission and Guiding Principles for the County* that highlights the county's core values and memorializes key priorities to be achieved by the Freeholder Board for the county. Freehold Myers further mentioned that in addition to the county's guiding principles, the Freeholder Board has adopted a resolution for the county to move forward with developing a county-wide strategic plan.

During the budget presentation, Mayor Harris and members of the Borough Council voiced their concerns that several matters communicated to county officials over the past year have gone unanswered and unaddressed.

Council Member Lonergan and Mayor Harris further mentioned that although Chatham Borough contributes \$6 million a year in taxes to the county, the Borough is not receiving anything close to that in return with road projects or other services.

Mayor Harris specifically mentioned that he has yet to hear back from anyone in the county regarding the Borough's draft proposal for a new train station that he submitted to the county earlier in the year. He asked Freeholder Myers and Mr. Bonanni if they would follow up with county officials to help put some pressure on the North Jersey Transportation Planning Authority ["NJTPA"] to move the Borough's new train station proposal forward since Borough officials have done as much as they can at this time. Freeholder Myers and Mr. Bonanni advised they would follow through and bring this to Freeholder DeFillippo's attention, who is the county representative on the NJTPA.

Council Member Resto raised the issue of his appointment to the Morris County Board of Transportation and how it has only met three times in the past two years. He indicated that the Board had not met or taken a position on the current diversion of Midtown Direct service to Hoboken and was largely absent from significant transportation issues. Freeholder Myers and Administrator Bonanni agreed to look into this.

Mayor Harris thanked Freeholder Myers and Mr. Bonanni for providing an informative budget presentation and stated he looks forward to a continued dialogue with county officials.

Project Community Pride – Council President Fife and Mr. Williams provided an update on Project Community Pride. Mr. Williams reported that he attended a recent Project Community Pride meeting and advised that 46 Borough residents are currently utilizing services provided by the program, representing 24% of the total participants in the program. Mr. Williams mentioned that the services offered through Project Community Pride help young individuals with behavioral health issues, including substance abuse, family conflict, trauma, grief, depression and anxiety. He noted that Madison Borough, Florham Park Borough, Chatham Borough and the School District of the Chathams currently participate and fund the program, which is administered by the Madison Area YMCA, and confirmed that Chatham Township does not participate in the program.

Council President Fife further reported that the New Jersey State League of Municipalities has invited elected officials in Madison Borough and Chatham Borough to participate in a panel discussion at this year's November conference so that officials in other municipalities can learn more about the Project Community Pride program and replicate similar programs in their communities.

Capital Projects Update – Mr. Vince DeNave, Borough Engineer, provided an update on the following 2017 capital projects:

- 1. Phase I of the Historic Riverside Trail will begin soon with construction of a 1/3 mile stone walkway path around the ballfields at Shepard Kollock Park followed by construction of a woodchip trail along the Passaic River.
- 2. Road resurfacing projects will be awarded to Tilcon through the Morris County Cooperative Pricing Council. Roads scheduled this year include Center Street, from Yale Street to its Northern terminus, Duchamp Place, Inwood Road, Second Street and Orchard Circle.
- 3. The 2017 Curb and Sidewalk Program will begin next week in Zone 5. Additional funds have been retained for sidewalk improvements at the Fairmount Avenue trestle and Borough Hall.
- 4. Bid specifications are being finalized for the Weston Avenue Road Reconstruction Project and, once finalized, will be issued for bid.
- 5. The Department of Public Works completed drainage projects along Lincoln Avenue, Clark Street and North Summit Avenue. Drainage projects on Myrtle Avenue and Red Road are scheduled for completion this summer.
- 6. The Department of Public Works will be completing the electric work and installation of the bubblers at Kelly's Pond.
- 7. Mr. DeNave reported electrical upgrades to Well #3 have been completed. Quotes are being obtained from contractors for the repainting of the water tank.
- 8. Water main breaks continue to occur on Watchung Avenue from the school entrance to Lafayette Avenue. Mr. DeNave reported that he is looking into whether the water main line can be relined.

He thanked the Madison Department of Health, Westfield Regional Health Department, Chatham Board of Health and Borough officials for the seamless transition. Megan Avallone, Westfield's Health Officer, will attend a future meeting to introduce herself and provide an overview of public health services to Chatham Borough.

MAYOR'S REPORT

Mayor Harris thanked the Chatham Fire Department Association for hosting and conducting a great Fourth of July parade and display of fireworks.

ADMINISTRATOR'S REPORT

Administrator Williams reported that the first Boxcar bus departed Chatham today with 25 Borough residents on board. The reported travel time to the Penn Station in New York City was approximately 51 minutes. He confirmed that the Department of Public Works installed the commuter bus parking signs at the Railroad Plaza North parking lot.

Mr. Williams reported that Megan Avallone, Health Officer for the Westfield Regional Department of Health, will attend a future meeting of the Mayor and Council to introduce herself and will present an overview of the array of public health services provided to Chatham Borough. He commended the Clerk's Office in their efforts in facilitating the transition from the Madison Department of Health and for updating the Chatham Borough Board of Health webpage.

He mentioned that the Morris County Sherriff's Office mobile outreach vehicle, "Hope One," will be at Kings Supermarket on July 24th from 10:00 a.m. to 2:00 p.m. and will provide free Narcan training, information and resources to individuals seeking assistance with substance addiction.

Lastly, Mr. Williams reported that the Borough submitted a grant application to the Morris County Park Commission seeking \$86,000.00 in grant funding for the Historic Riverside Trail Project. The grant request seeks funding to construct an observation deck over the Passaic River on the former trolley abutments.

- **WHEREAS,** Mr. Falzarano's many accomplishments include making financial management and budgeting the cornerstone of municipal administration and not just a task that was paid attention to at the beginning and end of each year; and
- **WHEREAS,** Mr. Falzarano's financial management also resulted in 10-year capital plans and identification of funding for needed municipal assets, and in combination with his budgeting practices allowed Moody's Investors Service to raise the Borough's bond rating to AAA; and
- WHEREAS, under his leadership the Borough made much needed improvements to its infrastructure, and especially to its roads, sewer and water infrastructure; and
- WHEREAS, Mr. Falzarano also oversaw the implementation of initiatives that helped make municipal government more open, including the introduction of the website and ensuring that a wide range of materials are posted and made readily available to residents, the installation of video equipment that allows meetings to be televised, the introduction of AlertChathamBorough, our emergency notification service, and the publication of an annual report covering the Borough's accomplishments.

RESOLUTION AUTHORIZING A 60-MONTH LEASE FOR A PITNEY BOWES SENDPRO P SERIES MAIL SYSTEM WITH PITNEY BOWES, INC. IN THE AMOUNT NOT TO EXCEED \$15,960.00

WHEREAS, the Borough's existing rental agreement with Pitney Bowes, Inc. ("Pitney Bowes") for the Borough's mail machine is scheduled to expire on July 31, 2017; and

WHEREAS, the Borough has received a proposal from Pitney Bowes for a SendPro P Series Mail System to replace the Borough's present mail machine, which includes yearly maintenance for all parts and labor; and

WHEREAS, the proposed new mail system is not available through the State of New Jersey Cooperative Purchasing Program; however, the Borough is able to achieve cost-savings and avoid the cost and time of a separate procurement process by using a National Governmental Purchasing Cooperative; and

WHEREAS, P.L. 2011, c.139 allows local contracting units to utilize national cooperative contracts as a method of procurement; and

WHEREAS, the Borough is a member in the National Joint Powers Alliance (NJPA), a National Governmental Purchasing Cooperative, which has publicly bid for postage meters and related mailing equipment, software, accessories and supplies, including Pitney Bowes mailing systems; and

WHEREAS, the Chief Financial Officer has recommended that the Borough enter into 60-month NJPA State and Local Term Rental Agreement with Pitney Bowes for a SendPro P Series Mail System once the present agreement expires; and

WHEREAS, the Chief Financial Officer has certified that the maximum dollar amount of the 60-month rental agreement shall not exceed \$15,960.00 and that funds are currently available for the purpose of awarding this contract and shall be encumbered in quarterly payments not to exceed \$796.26 over the term of the rental agreement from the Current Fund account #7-01-20-100-212, and will be subject to appropriations in the 2018, 2019, 2020, 2021 and 2022 Municipal Budgets; and

WHEREAS, Pitney Bowes has completed and submitted a Non-Collusion Affidavit and Stockholder Disclosure Certification, along with a Business Registration Certificate and Certificate of Employee Information Report demonstrating AA/EEO compliance as required by P.L. 2011, c.139.

RESOLUTION #17-235

RESOLUTION APPROVING THE CORRECTIVE ACTION PLAN FOR THE ANNUAL AUDIT REPORT FOR THE YEAR 2016

WHEREAS, the Division of Local Government Services has promulgated a regulation that each municipality shall prepare and submit a Corrective Action Plan that "shall cover all findings and recommendations in the audit report, including state, federal, and general findings, as well as the status of all prior year findings and recommendations" and that the governing body shall approve the Corrective Action Plan, and

WHEREAS, failure to comply with the promulgations of the Local Finance Board of the State of New Jersey may subject the members of the local governing body to the penalty provisions of R.S. 52:27BB-52 to wit:

"R.S. 52:27BB-52 - A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provision of the Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office."

WHEREAS, such resolution of certification shall be adopted by the governing body no later than forty-five days after the receipt of the annual audit, as per the regulations of the Local Finance Board, and

WHEREAS, the Mayor and Borough Council have reviewed and approved the Corrective Action Plan submitted by the Chief Financial Officer, a copy of which is attached and made a part of this resolution.

BE IT RESOLVED, by the Mayor and Council of the Borough of Chatham that the Corrective Action Plan submitted by the Chief Financial Officer is hereby approved; and

RESOLUTION AUTHORIZING THE EXECUTION OF AN AGREEMENT BETWEEN THE BOROUGH OF CHATHAM AND THE COUNTY OF MORRIS ESTABLISHING A COOPERATIVE MEANS OF CONDUCTING CERTAIN COMMUNITY DEVELOPMENT AND HOME ACTIVITIES PROGRAMS

WHEREAS, Title I of the Housing and Community Development Act of 1974, as amended, and Title II of the Cranston-Gonzales National Affordable Housing Act of 1990, commonly known as the HOME Investment Partnership Program under the Community Development Block Grant Program, provides for the allocation of substantial federal funds to eligible urban counties for use therein; and

WHEREAS, the Emergency Shelter Grant Program ("ESG"), provided through Subtitle B of the McKinney-Vento Homeless Assistance Act, provides for the allocation of substantial federal funds to eligible urban counties for use therein to prevent homelessness and to enable homeless individuals and families to move toward independent living; and

WHEREAS, the County of Morris (the "County") is eligible to receive federal funds available through the Department of Housing and Urban Development; and

WHEREAS, the Uniform Shared Services and Consolidation Act (N.J.S.A. 40A:65-1 et seq.) provides a mechanism through which counties and municipalities may enter into agreements for the provision of joint services; and

WHEREAS, the Mayor and Council of the Borough of Chatham wish to enter into an agreement with the County of Morris for Federal Fiscal Years 2018, 2019 and 2020, to address housing and homeless problems in accordance with the housing goals and strategies outlined in the Morris County Consolidated Plan within Morris County, New Jersey.

BE IT RESOLVED, by the Council of the Borough of Chatham, in the County of Morris, State of New Jersey that the Mayor is hereby authorized to sign the agreement entitled, "Agreement Between the County of Morris and the Borough of Chatham Establishing a Cooperative Means of Conducting Certain Community Development and HOME Activities Programs" with the County of Morris for Federal Fiscal Years 2018, 2019 and 2020; and

BE IT FURTHER RESOLVED that all other Borough officials and employees are hereby authorized and directed to take all action necessary and appropriate to effectuate the terms of this Resolution.

Council President Fife advised that Ordinance #17-08 revises the Borough's sign ordinance so that it is consistent with the U.S. Supreme Court decision in <u>Reed v. Town of Gilbert, Arizona</u> and asked Mr. Lott to provide further detail on the amendments to the ordinance.

Mr. Lott further advised that Ordinance #17-08 regulates the type, size, style and placement of commercial and non-commercial signage within the Borough. All non-commercial signs may be placed in the public right-of-way for not more than 30 days prior to an event date and must be removed within 5 days following the event date. Placement of non-commercial signs must be approved by the Zoning Officer prior to placement. He clarified that political signs are defined as non-commercial signs and are allowed in the public rights-of-way; however, they are not allowed on Borough property.

Council President Fife moved for introduction on First Reading.

ORDINANCE #07-09

ORDINANCE OF THE BOROUGH OF CHATHAM, COUNTY OF MORRIS, STATE OF NEW JERSEY, ADOPTING NEW CHAPTER 189 AND AMENDING CHAPTER 165 OF THE CODE OF THE BOROUGH OF CHATHAM AND PROVIDING REGULATIONS APPLICABLE TO OIL AND HAZARDOUS SUBSTANCE PIPELINES

Council Member Resto explained that the purpose of this ordinance is to regulate oil and hazardous pipelines and to specifically provide that those pipelines that are not public utilities and are not regulated by the New Jersey Board of Public Utilities ("BPU") are specifically prohibited within the residential and affordable housing zone districts. He mentioned that the attorney retained by the Municipal Pipeline Group recommends the adoption of this ordinance as a pre-emptive measure should the Pilgrim Pipeline, or any other pipeline not regulated by the BPU, move through the approval process and threaten to construct a pipeline through the Borough, which may impact the health of welfare of our residents.

Council Member Resto moved for introduction on First Reading.
