Council Member Weber motioned to approve Resolution # 20-131, seconded by Council Member Dempsey. By a unanimous voice vote, Resolution # 20-131 was approved.

DISCUSSION ITEMS

Board of Health and Department of Health Activities/ Coronavirus Presentation

Megan Avallone, Chatham Borough Health Officer and Lisa DeRosa, the President of the Board of Health came forward and presented on the Coronavirus pandemic and the Board of Health response. Mrs. Avallone explained that the virus spreads in a similar fashion as the common cold/flu. Measures to prevent the spread of the virus includes washing one's hands effectively and frequently, and to self-quarantine if feeling ill. As many people feel comfortable and safer wearing facial masks, a mask does not protect against the virus. However, she cautioned to avoid touching one's face. The public was advised to contact their physician should they suspect they have contracted the coronavirus.

Mrs. Avallone advised the public to contact their health care provider should they experience a fever of 100.4 degrees, and not to overwhelm the hospitals, unless urgent medical care is necessary. Avoiding the hospital and urgent-care facilities will reduce the risk of proliferating the virus. In addition to avoiding the emergency room and urgent care, the pubic was advised to avoid calling 9-1-1 due to a fever and or a cough. She further reported that over the weekend LabCorp began testing residents for the Coronavirus without using any special equipment.

To date, the Borough of Chatham does not have a positive case of the Coronavirus. However, should that change, the Health Department will follow up and will be responsible for all infected individuals being quarantined.

Mrs. Avallone reported that the Health Department is providing daily updates on the Borough's website and social media. The public can also contact the Westfield Regional Health Department directly: 908-789-4070.

Mayor Kobylarz informed the public that Governor Murphy declared a State Emergency Declaration an hour and a half ago. The Borough's attorney, Mr. Lott stressed that no one should panic over the Declaration of Emergency. The Executive Order is largely an emergency measure designed to enhance planning and coordination between different levels of government, Mr. Lott explained.

Mayor Kobylarz thanked Mrs. Avallone and Mrs. DeRosa for their presentation.

Mayor Kobylarz reported that the Borough implemented a Coronavirus Task Force, whose job is to closely monitor the latest developments, coordinate with various Borough departments, and establish protocols for implementation, as conditions require. He also reviewed the sanitary health measures that are currently in place.

Mayor Kobylarz proceeded to open the meeting to the public; however, prior to doing so, he delivered a portion of his Mayor's Report.

Mayor Kobylarz reported that Robert Powell of Nassau Capital Advisory Group will meet with the governing body in Executive Session to provide his preliminary thoughts on the River Road Development Project. With respect to the Post Office Plaza Redevelopment Project, Mayor Kobylarz stated that an examination of municipal planners will continue in order to provide an alternative vision for the area. Additionally, efforts are being made to retain a firm to handle future Town Hall meetings and other public outreach efforts, including a survey. Lastly, he announced he will continue to update residents throughout the process.

MEETING OPEN TO THE PUBLIC

NOTICE OF PUBLIC COMMENT TIME LIMIT

Hearing of citizens during the Public Comment section of the Agenda is an opportunity for any member of the public to be heard about issues which are/are not topics scheduled for Public Hearing tonight. To help facilitate an orderly meeting, and to permit all to be heard, speakers are asked to limit their comments to a reasonable length of time.

Rozella Clyde – 33 Carmine Street:

Dr. Clyde informed residents of the Census letter to be mailed in the coming weeks. She reminded everyone that kiosks will be available at the Library of the Chathams for those without internet access or in need of assistance locating the Census website. Residents also have the option to call the Census

phoneline directly to complete the survey.

Tom Belding-7 Milton Avenue:

Mr. Belding asked if mail facilities, drive-up windows, etc. are safe to use as a result of the Coronavirus pandemic.

Mayor Kobylarz answered that the Borough is examining these everyday situations logistically. He noted that food and medicine deliveries to the elderly in the community must be considered. The Health Department and the Borough are discussing plans to handle these various situations.

Stewart Carr - 3 Crestwood Drive, Chatham Township:

Mr. Carr stated that a matrix decision-making criterion with different options should be considered for the Post Office Plaza Redevelopment Project, as opposed to a single option plan.

Mayor Kobylarz stated that a broad range of options will be examined.

Mr. Carr inquired about future parking at Post Office Plaza and the costs involved. Additionally, he asked for clarification on the potential revenue to be generated to the Borough from the Post Office Plaza and River Road Redevelopment Projects.

Council President Mathiasen reported that the governing body is in the process of having conversations with the two designated developers. However, currently, it is not appropriate to publicly report on these conversations.

Mayor Kobylarz assured Mr. Carr that this information will be made public at the appropriate time.

Which Ordinance was introduced and passed on first reading at a regular Council meeting held on February 24, 2020.

Mayor Kobylarz asked the Borough Clerk to give a summary of the legal notice.

The Borough Clerk stated that a legal notice was published indicating that Ordinance #20-02 was introduced and passed on first reading at the February 24, 2020 meeting and indicated the second reading and public hearing would be held at 7:30 p.m. on March 9, 2020 for consideration of final adoption. Copies of this Ordinance were made available to the general public and posted in accordance with the law.

Mayor Kobylarz opened the public hearing on the Ordinance and invited any member of the public to be heard.

Mayor Kobylarz declared the Ordinance adopted and finally passed and requested the Borough Clerk to publish the proper notice of adoption of this Ordinance in the official newspapers and to permanently record the Ordinance.

REPORTS

COUNCIL COMMITTEES

Budget and Finance - Council President Mathiasen informed the public that the Budget and Finance Committee will meet during the second week of March to review a budget analysis for pension and health care coverage costs for the year 2020. A budget presentation will be made in the near future.

Long Range Traffic & Pedestrian Safety Planning - Council Member Koronkiewicz reported that the Committee met in February to discuss residents' concerns about parking at Parrott Mill Road near KinderCare. The parking has been reconfigured to provide additional handicapped parking. The new parking spaces will be on the west side of Parrot Mill Road. The Borough is working with the County to obtain signage for trucks to be routed onto Lafayette Avenue.

Public Safety & Emergency Services - Council Member Weber had nothing to report.

Personnel - Council Member Resto informed the public that the Committee will meet in the upcoming weeks to review potential CFO applicants and to discuss the current staff budget.

Public Works Planning/Community Services - Council Member Dempsey informed the public that Community Services is working on the following:

- Borough Hall Open House scheduled for April 24, 2020 from 8 a.m. 4 p.m.;
- A guided tour at Shepard Kollock Park on April 25, 2020;
- Spring Clean scheduled for May 2, 2020 from 8 a.m.- 1:00 p.m.; and
- Fishawack Festival and Farmers Market scheduled to begin on June 20, 2020 from 8 a.m. 1:00 p.m.

Council Member Dempsey announced that the Department of Community Services is currently looking for sponsors for the Concert Series, with the first one to be held on Thursday June 25, 2020 at 6:00 p.m.

The Department of Public Works completed the following:

- Rails on the steps at Shepard Kollock Park, benches were installed on the Riverside Trail;
- New curbs and sidewalks on Center Street are now complete;
- Installation of new sidewalks on Lafayette Avenue;
- Ballfields will be cleaned for the Spring and Summer seasons;
- The paving of damaged asphalt on Woodland Road has been complete;
- Trimming of trees on the needed streets will begin, soon;
- Sanitization measures will be handled daily around Borough Hall due to the Coronavirus;
- Kiosks will be installed at the Library of the Chathams with respect to the 2020 Census;

- D.P.W. will be inspecting playground equipment; and
- Brush collection will be held on March 16th, 2020.

On a final note, Council Member Dempsey informed residents that Stanley Congregational Church will be hosting a free final community concert on March 29, 2020.

Shared Services & 3rd Party Agreements - Council Member Treloar reported that the Borough is currently working on a spreadsheet to reflect all current third-party agreements. The Committee is also considering a shared service agreement with the Township of Chatham for a Certified Pool Operator.

MAYOR'S REPORT

Mayor Kobylarz reported that the Economic Development Advisory Committee met on Feb 26, 2020 to examine various areas such as Main Street and the economic needs in the Borough of Chatham. The next meeting will be held on March 25, 2020 with a presentation from a downtown planning expert examining the challenges confronting the downtown commercial district due to online retail. The first-roundtable meeting will be held next week with the Chatham Robotics Team to discuss traffic flow challenges in Chatham Borough.

ADMINISTRATOR'S REPORT

Mr. Williams reported that the curbside brush pickup is scheduled for March 16, 2020. Additionally, the Garden Park survey is currently ongoing with a total of 125 responses on the Borough's website and social media. In the upcoming weeks, a survey will be emailed to residents. PSE&G gas replacement program continues in the Borough. Mr. Williams asked residents to be patient as the roads will be fully paved once the weather changes. He also noted that the Borough is saving significantly on paving costs. Residents with concerns should contact PSE&G hotline at 1-833-661-6300.

Mr. Williams further reported that a meeting was held with Tri-Town 55 on February 25, 2020 to evaluate the need for senior housing and transportation in Chatham Township, Madison Borough and Chatham Borough. Two additional meetings will be held on March 25, 2020 and March 29, 2020 for further evaluation. Jersey Central Power and Light will be conducting tree trimming in June of 2020 on Center Place, North Passaic Avenue, Rutgers Street and Yale Street; additional information will be provided in the near future. Mr. Williams also provided information about the hand sanitizing stations located throughout Chatham Borough Hall and advised residents to use hand sanitizer before conducting business with Borough staff.

WHEREAS, pursuant to N.J.A.C. 5:34-3.4(f) each member of the Evaluation Committee executed a certification that they do not have a conflict of interest with any of the respondents; and

WHEREAS, the Evaluation Committee reviewed and scored the proposal submitted by Appraisal Systems, Inc. and issued an Evaluation Report (the "Report"), attached hereto as Exhibit A, finding that the proposal is substantially responsive to the RFP and meets the Evaluation Criteria set forth therein; and

WHEREAS, the Report recommends the award of contract to Appraisal Systems, Inc.; and

WHEREAS, based on this recommendation, the Borough desires to award the contract for the revaluation of all real properties situated in the Borough of Chatham for the Year 2021 to Appraisal Systems, Inc. in the amount of \$251,045.00, as well as a rate of \$125 per hour for Option A related to appeals made to the Tax Court of New Jersey, all as per the proposal submitted by Appraisal Systems, Inc. dated February 27, 2020; and

WHEREAS, the Chief Financial Officer has certified in writing that funds are available for this purpose.

RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE A DISTRACTED DRIVER ENFORCEMENT GRANT APPLICATION WITH THE STATE OF NEW JERSEY, DEPARTMENT OF LAW AND PUBLIC SAFETY, DIVISION OF HIGHWAY TRAFFIC SAFETY

WHEREAS, distracted driving is a dangerous epidemic on America's roadways. In 2017 alone, 3,116 people were killed in distracted driving crashes. In New Jersey, driver inattention remains the most significant cause of fatal and incapacitating crashes. Driver inattention was listed as a contributing circumstance in 51 percent of the state's crashes in 2017. Driver inattention was in fact listed as a contributing factor in crashes at a rate more than eight times higher than that of the next highest contributing factor; and

WHEREAS, April is National Distracted Driver Month, which is a time to remind New Jersey motorists of the state's distracted driving laws, which include a ban on hand-held cell phone use and text messaging by all drivers and a ban on all cell phone use (hand-held); and

WHEREAS, the State of New Jersey, Department of Law and Public Safety, Division of Highway Traffic Safety is offering law enforcement agencies throughout New Jersey and the nation an opportunity to participate in a federally-funded grant program sponsored by the National Highway Traffic Safety Administration to help raise awareness about the dangers of distracted driving through visible enforcement and issuance of summonses for relevant motor vehicle violations from April 1, 2020 through April 21, 2020; and

WHEREAS, funding offered by the National Highway Traffic Safety Administration is a reimbursable grant requiring the municipality to fund its distracted driving enforcement campaign upfront; and

WHEREAS, the Mayor and Council of the Borough of Chatham desires to participate in the distracted driver enforcement campaign and is requesting \$5,500.00 in grant funding; and

WHEREAS, if the grant request is approved, the Chief Financial Officer will certify via a separate resolution for the approval of the Borough of Chatham Council that sufficient funds are available in the amount of \$5,500.00 for the execution of the enforcement of this reimbursable grant program.

BE IT RESOLVED, by the Council of the Borough of Chatham that they hereby approve the submission of a grant application and authorize the Mayor to execute the State of New Jersey, Department of Law and Public Safety, Division of Highway Traffic Safety grant application for the Distracted Driver Enforcement campaign from April 1, 2020 through April 21, 2020.

WHEREAS, to serve the continuous growth and usage of services, the Library building was expanded in 1940, 1960, 1964, 1983, 1991 and 2004 to its present size and configuration; and

WHEREAS, the Library has conducted consumer research including focus groups, community surveys and interviews with community leaders to ensure that present services satisfy present needs and to identify new and emerging needs of the communities including an enclosed collaborative Teen Space, an enhanced Local History Room, additional private study rooms, a Business Center, a combination STEAM/Meeting Room, an enlarged and dividable Community Room, a Children's Activity Room, rear entrance and access ramp improvements; and

WHEREAS, an engineering study in 2014 identified structural, operational and environmental deficiencies in the present building requiring correction including HVAC system deficiencies and energy savings; and

WHEREAS, the Library Board of Trustees has engaged architects to develop a plan, called *Bridging Space to Place* to address these deficiencies and reconfigure the spaces within the building to accommodate emerging needs and the growth in demand for present services; and
