Mayor Thaddeus J. Kobylarz called the Regular Council Meeting of the Borough of Chatham to order on Monday, November 23, 2020, at 6:11 p.m. in the Council Chambers in Borough Hall, 54 Fairmount Avenue, Chatham, New Jersey.

RESOLUTION TO ADOPT COUNCIL MEETING MINUTES

BE IT RESOLVED, by the Council of the Borough of Chatham that the minutes from the following meeting are approved as prepared and shall be filed as a permanent record in the Borough Clerk's office:

October 26, 2020

Council Member Resto moved to approve Resolution # 20-253, seconded by Council Member Weber. By a unanimous voice vote, Resolution # 20-253 was approved.

DISCUSSION ITEMS

Finance Update:

Mrs. Fornaro reported on the deficit in the Borough's budget resulting from a significant loss of revenue from parking permits and the Joint Municipal Court. The Borough anticipated \$440,000 in parking permits, but only received approximately \$70,000. With respect to the Joint Municipal Court, \$122,000 in revenue was anticipated, however, it is projected that only \$44,000 will be received by year-end.

Municipalities are permitted to declare a special emergency appropriation in accordance with N.J.S.A. 40A:4-53, 54 and 55.1. To avoid a cumbersome burden on the 2020 budget, the special emergency appropriation will allow lost revenue to be spread throughout the next three to five years of the Borough's budget. On tonight's agenda, Ordinance # 20-17 and Resolution #20-254 and Resolution # 20-255 will authorize the Borough to apply for special emergency appropriation.

MAYOR'S REPORT I:

Mayor Kobylarz delivered a portion of his Mayor's Report as follows:

Statistical Update on the Coronavirus:

Mayor Kobylarz reported that 136 residents of the Borough contracted COVID-19. Borough Health Officer Megan Avallone is concerned about the potential consequences of families gathering together to celebrate Thanksgiving. Holidays are considered high risk for a contagious virus, which spreads expeditiously indoors. There is a dramatic increase in daily infection cases state-wide.

The surge in coronavirus cases is a result of our behavior. As a community, to mitigate the spread of the virus, we must put forth more effort and adhere to the protective measures of washing hands, maintaining social distancing, wearing masks, cooperating with contact tracing, and refraining from indoor gatherings.

COVID-19 Ambassador Program:

Mayor Kobylarz called for additional volunteers to participate in the COVID-19 Ambassador Program to gently remind the public to "Mask Up, Chatham". Residents were encouraged to volunteer by contacting Chatham Borough Police Chief, Brian Gibbons or Borough Administrator, Stephen Williams.

Mayor Kobylarz proceeded to open the meeting to public comment and read the Notice of Public Comment Time Limit.

To help facilitate an orderly meeting, and to permit all to be heard, speakers are asked to limit their comments to a reasonable length of time.

Mike Holland - 30 Broadview Terrance

Mr. Holland, president of Chatham Basketball Club called to begin a dialogue with the Council concerning refurbishing outdoor basketball courts for use by children in the spring season.

Mayor Kobylarz advised Mr. Holland to contact the Chatham Borough Recreation Committee and the Joint Recreation Committee. Council Member Weber stated that the Joint Recreation Committee will be discussing winter sports and outdoor spaces for public use should indoor activities becomes prohibited at its next meeting.

Seeing no one else wishing to be heard, Mayor Kobylarz closed the meeting to the public.

REPORTS COUNCIL MEMBERS

Council President Mathiasen – Council President Mathiasen had nothing new to report.

Council Member Weber – Council Member Weber reported that the Board of Health continues to discuss options on supporting the Borough during the current pandemic. The primary concern is helping to keep schools open and to help residents remain safe and healthy. He encouraged residents to do their part and follow all protective measures to mitigate the spread of the virus.

Council Member Dempsey – Council Member Dempsey reported on the Chatham Community Food Distribution program, which provides food to residents experiencing economic hardship. With gratitude, she happily announced the receipt of over 140 boxes of food and 60 turkeys for distribution. The boxes and turkeys were distributed to residents last Wednesday. The distribution of food takes place every Wednesday, from 3:30 p.m. to 4:30 p.m., behind the Chatham United Methodist Church.

Council Member Koronkiewicz – Council Member Koronkiewicz had nothing new to report.

Council Member Treloar – Council Member Treloar had nothing new to report.

Council Member Resto – Council Member Resto encouraged residents to support local businesses during this challenging time. Small Business Saturday is this weekend and he encouraged residents to shop locally. Lastly, the Undergrounding Committee and BPU (Board of Public Utilities) will examine the financials of Jersey Central Power and Light (JCP&L) due to the termination of FirstEnergy's CEO on alleged bribery charges. Residents were encouraged to visit the BPU's website to obtain additional information.

MAYOR'S REPORT II

Mayor Kobylarz had nothing further to report.

ADMINISTRATOR'S REPORT

Mr. Williams reported that PSE&G continues to work on Main Street. The paving project will be completed this week.

COVID-19 SPECIAL EMERGENCY CERTIFICATION OF CHIEF FINANCIAL OFFICER AND APPROVAL OF GOVERNMENT BODY

WHEREAS, The Borough of Chatham has experienced COVID-19 related revenue loss during budget year 2020; and

WHEREAS, P.L. 2020, c. 74 provides for the funding of these revenue losses and extraordinary expenditures through a COVID-19 Special Emergency; and

WHEREAS, in order to qualify for a special emergency under the provisions of N.J.S.A. 40A: 4-53, as amended by P.L.2020, c. 74, the Borough must, prior to December 1, make application to the Director of the Division of Local Government Services to obtain an approval of the certification of the special emergency and the resulting deferred charge in advance of the close of budget year 2020; and

WHEREAS, the Chief Financial Officer has determined that there is an operational gap attributable to COVID -19 affected revenue loss which needs to be addressed prior to year-end.

NOW, THEREFORE BE IT RESOLVED, by the Borough Council of the Borough of Chatham (by not less than a majority vote of the full governing body members affirmatively concurring), in accordance with the provisions of N.J.S.A 40A:4-53, as amended by P.L. 2020, c. 74, as follows:

- 1. The Chief Financial Officer is directed to submit an application to the Division Director on the prescribed form and shall certify that the deficits in revenue are directly attributable to COVID-19.
- 2. The Chief Financial Officer has submitted said certification to the governing body for approval (attached to this resolution).
- 3. The Borough Council by approval of this resolution approves the certification made by the Chief Financial Officer related to COVID-19 Special Emergencies.
- 4. The Borough Council directs the Chief Financial Officer, the Auditor and Bond Counsel to prepare the Ordinance and Resolution for Special Emergency COVID-19 related revenue deficit pursuant to statute and regulations resulting from P.L.2020, c. 74.
- 5. That two (2) certified copies of this resolution will be filed with the Director of the Division of Local Government Services.

COVID -19 SPECIAL EMERGENCY RESOLUTION- N.J.S.A 40A:4-53, 54, 55.1 and 55.1

(3-year and 5-year Special Emergencies COVID-19 Related Operating Deficits)

WHEREAS, it has been found necessary to adopt a Special Emergency Appropriation to meet certain extraordinary COVID-19 affected revenue losses related to the COVID pandemic, and

WHEREAS, N.J.S.A. 40A:4-53 allows a municipality to authorize special emergency appropriations for COVID-19 related revenue loss and/or additional expenditures incurred during the COVID-19 related public health emergency, and provides that it shall be lawful to adopt such special emergency, which appropriation and/or the "special emergency notes" issued to finance the same shall be provided for in succeeding annual budgets by the inclusion of an appropriation as prescribed by the act and in compliance with the Division of Local Government Services regulations set forth as part of the COVID-19 Operating Deficits and Extraordinary Expenditures: Implementation of P.L. 2020, c.74.

NOW, THEREFORE BE IT RESOLVED, (by not less 2/3 vote of the full governing body members affirmatively concurring) that in accordance with the provisions of N.J.S.A 40A:4-55:

- 1. The Chief Financial Officer has been directed by Resolution # 20-254 adopted on November 23, 2020 to make a written application and certify to the Division Director, on the prescribed form, that the deficits in revenue are directly attributable to COVID-19, and said certification was approved by the governing body and submitted to the Director of the Division of Local Government Services.
- 2. A Special Emergency Deferred Charge is hereby established for COVID-19 affected revenue losses in the total amount of \$300,000.
- 3. That the total emergency appropriation shall be provided for in the budgets of succeeding years beginning in 2022 by the inclusion of not less than \$60,000 (must be at least one fifth of the total amount).
- 4. That special emergency notes, not in excess of the amount authorized pursuant to law, may be issued.
- 5. That such notes when issued shall be executed by Borough of Chatham's Chief Financial Officer, Mayor and Borough Clerk. The Chief Financial Officer is hereby authorized to sell said notes and any renewals thereof from time to time.
- 6. That said Special Emergency Notes may be issued to address the cash flow and appropriation needs related to the deferred charge in compliance with the provisions of P.L. 2020, c.74.
- 7. That two (2) certified copies of this resolution will be filed with the Director of the Division of Local Government Services.
