# RESOLUTION SUPPORTING THE $16^{TH}$ ANNUAL TURN THE TOWNS TEAL® CAMPAIGN, A NATIONAL CAMPAIGN PROMOTING AWARENESS OF OVARIAN CANCER AND ITS SYMPTOMS

**WHEREAS**, ovarian cancer is the fifth leading cause of cancer-related death among women in the United States; and

WHEREAS, the month of September is dedicated to raising awareness of ovarian cancer; and

WHEREAS, ovarian cancer is called the "silent disease" because its symptoms are often vague or subtle; and

**WHEREAS**, if detected in its early stages, the survival rate from ovarian cancer is 90-95 percent, yet the relative five-year survival rate for ovarian cancer is 46 percent because it is so difficult to detect early. Survival rates vary greatly depending on the stage of diagnosis; and

WHEREAS, the Turn The Towns Teal<sup>®</sup>, a national campaign to promote awareness of ovarian cancer and its symptoms, was the inspiration of Gail MacNeil of Chatham, New Jersey during her 10-year battle with

ovarian cancer. This campaign continues to go forward in her name and in her honor; and **WHEREAS**, Turn The Towns Teal<sup>®</sup> and the Ovarian Cancer Research Fund Alliance (OCRFA) are partnering to promote awareness of ovarian cancer through the Turn The Towns Teal<sup>®</sup> campaign.

**NOW, THEREFORE, BE IT RESOLVED,** by the Mayor and Council of the Borough of Chatham that they hereby support the Turn The Towns Teal® campaign, a national campaign to promote awareness of ovarian cancer and its symptoms, and authorize the placement of teal colored ribbons around Borough trees during the month of September; and

#### GOVERNING BODY CERTIFICATION OF THE ANNUAL AUDIT

**WHEREAS**, N.J.S.A. 40A: 5-4 requires the governing body of every local unit to have made an annual audit of its books, accounts and financial transactions, and

**WHEREAS**, the Annual Report of Audit for the year 2021 has been filed by a Registered Municipal Accountant with the Borough Clerk pursuant to N.J.S.A. 40A: 5-6, and a copy has been received by each member of the governing body; and

**WHEREAS**, R.S. 52:27BB-34 authorizes the Local Finance Board of the State of New Jersey to prescribe reports pertaining to the local fiscal affairs; and

**WHEREAS**, the Local Finance Board has promulgated N.J.A.C. 5:30-6.5, a regulation requiring that the governing body of each municipality shall, by resolution, certify to the Local Finance Board of the State of New Jersey that all members of the governing body have reviewed, at a minimum, the sections of the annual audit entitled "Comments and Recommendations; and

WHEREAS, the members of the governing body have personally reviewed, at a minimum, the Annual Report of Audit, and specifically the sections of the Annual Audit entitled "Comments and Recommendations, as evidenced by the group affidavit form of the governing body attached hereto; and

**WHEREAS**, such resolution of certification shall be adopted by the Governing Body no later than forty-five days after the receipt of the annual audit, pursuant to N.J.A.C. 5:30-6.5; and

WHEREAS, all members of the governing body have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board; and

**WHEREAS**, failure to comply with the regulations of the Local Finance Board of the State of New Jersey may subject the members of the local governing body to the penalty provisions of R.S. 52:27BB-52, to wit:

R.S. 52:27BB-52: A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his/her office.

**NOW, THEREFORE BE IT RESOLVED,** That the Borough Council of the Borough of Chatham, hereby states that it has complied with N.J.A.C. 5:30-6.5 and does hereby submit a certified copy of this resolution and the required affidavit to said Board to show evidence of said compliance.

#### ORDINANCES FOR SECOND READING

Council Member Koronkiewicz read Ordinance #22-07 by title:

#### **ORDINANCE #22-07**

AN ORDINANCE TO AMEND THE CODE OF THE BOROUGH OF CHATHAM CHAPTER 139 THEREOF, ENTITLED "VEHICLES AND TRAFFIC" TO ADD A "STOP" SIGN ON TALLMADGE AVENUE AND MAIN STREET

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Council of the Borough of Chatham, County of Morris, State of New Jersey as follows:

Article V. Chapter 139 of the Code of the Borough of Chatham, Section 139-31 thereof, entitled "Stop Intersections" is hereby amended to add the following:

#### § 139-31. Schedule IX: Stop Intersections.

In accordance with the provisions of § 139-15, the following described intersections are hereby designated as stop intersections:

Stop Sign on At Intersection of

Tallmadge Avenue Main Street

- **Section 1.** All other provisions of the Borough Code not amended or supplemented herein remain in full force and effect.
- **Section 2.** If any section, paragraph, subsection, clause or provision of this Ordinance shall be adjudged by the courts to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause or provisions so adjudicated, and the remainder of the Ordinance shall be deemed valid and effective. Any ordinances or parts thereof in conflict with the provisions of this Ordinance are repealed to the extent of such conflict.
- **Section 3.** This Ordinance shall take effect upon passage and publication in accordance with applicable law.

Borough Clerk Nienhouse read the following statement:

A legal notice was published indicating that Ordinance #22-07 was introduced and passed on first reading at the July 11, 2022, meeting and indicated the second reading and public hearing would be held at 7:30 pm on August 8, 2022, for consideration of final adoption. Copies of this Ordinance were made available to the general public and posted in accordance with the law.

Mayor Kobylarz opened the meeting for a public hearing on the Ordinance.

Michael Dean – 181 North Passaic Ave. – Asked if the state was consulted in the installation of the stop sign. Attorney Kleinman and Administrator Williams responded.

Council Member Koronkiewicz – Commented on National Night Out and thanked all that were involved in putting it together.

Council Member Resto – Economic Development Advisory Committee has been speaking with local businesses seeking their opinions on the details of having a business in Chatham. He also spoke about the food distribution in town and asked for donations.

Council Member Truilo –Gave an overview on an Historic Preservation Commission application received by Terrace Apartments.

#### ADMINISTRATOR'S REPORT

The basketball courts are almost done and urged residents to stay off the courts until complete. Nine roads in the Borough will be micro surfaced beginning in August. The curb and sidewalk program will begin in September and the milling and paving will be done shortly after. Verizon outage in the Borough

was caused by utility company crushing a fiber optic cable in Madison. Lastly, the Governor extended the outdoor dining option.

WHEREAS, the Borough of Chatham wishes to install new carpets in the Stanley Center; and

**WHEREAS**, the purchasing agent has determined and certified in writing that the value of the purchase exceeds \$17,500; and can be awarded as a non-fair and open contract pursuant to the provisions of N.J.S.A. 19:44A-20.4 and 20.5 as appropriate; and

**WHEREAS**, because the anticipated contract amount is less than the Borough's bid threshold of \$44,000.00, but 15% or more of that amount, the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq., requires the Borough to solicit at least two (2) competitive quotations for said work; and

**WHEREAS,** the Borough of Chatham Department of Public Works solicited two quotations and Best Carpets and Interiors provided the lowest responsive quotation to install new carpets in the Stanley Center in the amount not to exceed \$41,390; and

WHEREAS, Best Carpets and Interiors has completed and submitted a Business Entity Disclosure Certification which certifies that Best Carpet Interiors has not made any reportable contributions to a political or candidate committee in the Borough of Chatham in the previous one year, and that the contract will prohibit Best Carpet Interiors from making any reportable contributions through the term of the contract; and

**WHEREAS**, upon the recommendation of the Department of Public Works and the Borough's Qualified Purchasing Agent, the Borough Council wishes to authorize a non-fair and open contract with Best Carpet Interiors, in accordance with the scope of work and contract amount set forth in its proposal; and

**WHEREAS**, Borough of Chatham's Chief Financial Officer has certified that there are funds available in the general trust account T-17-56-000-229; and

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the Borough of Chatham, County of Morris, State of New Jersey that a contract be processed and awarded to Best Carpets and Interiors in the amount not to exceed \$41,390.

RESOLUTION AUTHORIZING THE AWARD OF NON-FAIR AND OPEN PROFESSIONAL SERVICES CONTRACTS FOR AUDITING SERVICES TO REVIEW THE CONNECTION FEE FOR WATER AND SEWER SERVICES

**WHEREAS**, there exists a need to enter into non-fair and open professional services contract auditing services to review the connections fees for water and sewer services pursuant to the provisions of N.J.S.A. 40A:11-5(1)(a); and

**WHEREAS**, such services constitute professional services as defined by the New Jersey Local Public Contracts Law, N.J.S.A. 40A:11-5(1)(a)(i) and N.J.S.A. 19:44A-20.5, which may be awarded without advertisement for bids or bidding in that the required services must be performed by persons authorized by law to practice a recognized profession, whose practice is regulated by law, of the performance of which requires knowledge of an advanced and specialized type; and

**WHEREAS**, Nisivoccia LLP possesses the experience necessary in their respective profession and the Mayor and Council have determined that the award of the contract would be in the best interests of the Borough; and
